## 2. Approval of the Minutes of the Council Meeting on 5th November 2021

Input from Roman Kumpost had one remark according full membership of Slovakia. We did not mention which association we accepted for full membership.

The <u>Council approved the minutes</u> from the meeting on 5<sup>th</sup> November 2021 and notes that they had been redacted for details due to the confidential nature of some of the discussions.

#### 3. Legal Updates

# A. Infront non-payment of 700,000 Euros 2021 Alpine and Nordic World Ski Championships:

In order to help Infront, FIS made a claim under its insurance policy in the amount of 4.7 million Euros. The FIS insurance policy contained disruption cover, whereas the agreement between FIS and Infront had no such reductions whereby Infront could have made reduction claims against FIS. Despite the goodwill extended by FIS to retrieve 4 million Euros under the insurance policy, Infront has refused to pay.

#### B. Infront injunction against FIS:

The position of FIS is that the injunction should be vacated. The injunction does not involve any National Ski Associations.

#### C. FIS Marketing AG injunction against FIS:

The position of FIS is that the injunction should be vacated.

# D. Infront Letter dated January 25<sup>th</sup> 2022 addressed to FIS Council Members: It was reported that Infront had sent a letter to the FIS Council Members making false statements.

#### 6. Olympic Winter Games 2022 Beijing

Secretary General Michel Vion provided the latest update with eight days to go before the Opening Ceremony. Some of the FIS team is already on site and so far, they have provided positive feedback. The biggest challenge for most people right now is traveling into the county. On the sports side all of the venues are perfectly prepared and look very impressive.

There is one case that was recently brought forward by a few Russian athletes who could not attend some of the qualification races in North America. This is an ongoing case with CAS.

#### 7. 53rd International Ski Congress

The Congress is currently scheduled to take place in Vilamoura (POR) at the end of May. Due to financial commitments for booking the hotel and flights FIS needs to make a decision if the Congress will be held in person in Portugal.

It was proposed that FIS take an additional 30 days to assess the situation with the pandemic and have a full discussion at the end of February.

The <u>Council agreed</u> to delay the decision on the Congress format and location until the end of February.

#### 6. Any other business

Dexter Paine asked about the status of the Freestyle Ski events scheduled to take place in March in Kazakhstan. He was informed that due to the current situation in Kazakhstan those events have been cancelled.

Roman Kumpost provided the latest update on the Fluor Wax ban and the development of the hand-held detector.

#### 7. Next FIS Council Meeting

The Council is asked to reserve 7<sup>th</sup> April 2022 as the date for a Council Meeting in preparation of the 53<sup>rd</sup> International Congress.
