3. Approval of the Agenda

The <u>Council approved</u> today's agenda, which was requested by some Council members.

4. Approval of the Minutes from the last Council Meeting 7th April 2022

The Council approved the minutes of last Council Meeting.

5. Legal Matters

The President informed the Council that the injunction filed by Tridem, was denied by the Zurich District Court. This was a legal victory for FIS.

The <u>Council approved</u> that a new FIS sponsorship and marketing organisation should be implemented as soon as possible.

5.1 <u>Centralized Marketing Concepts</u>

The Council voiced its full support for exploring a suitable path to centralizing the commercial exploitation of the WC media and broadcast rights.

The President proposed and the <u>Council approved</u> having a consultation process with the NSAs regularly hosting WC Events to discuss the various implications and solutions regarding the implementation of a centralized commercial exploitation of the WC media and broadcast rights.

6. FIS World Cup Calendars

In connection to the centralization discussion, the President stated that the goal of changes to the World Cup calendars is to make improvements.

The <u>Council approved</u> giving the FIS management discretion to find a solution to stage a men's downhill in Garmisch. The various stakeholders will be contacted.

The <u>Council approved</u> giving the FIS FS/SB/FK committee the chance to explore solutions to hold combined Ski and Snowboard Cross events.

7. Closing of the Meeting

The President closed the Council meeting. The next meeting will be 25th May in Milan.
