


CALCULATION SYSTEM

Same logic as voting rights of FIS Member Associations:



NSA FINANCIAL SUPPORT



- 1. BASIC AMOUNT (12.5%)
- DIVIDED AMONG ALL ORDINARY
 MEMBERS
- 2. ADDITIONAL SHARES (87.5%)
- 2.1 PARTICIPANTS AT FIS ALPINE AND NORDIC WORLD SKI
 - CHAMPIONSHIPS PARTICIPANTS
- 2.2 ACTIVE REGISTERED ATHLETES
- 2.3 ORGANISATION OF FIS COMPETITIONS



Calculation of Financial Support

- 1. Basic Amount
- 12.5% of the total Financial Support
- Only full members are eligible for the basic amount
- Amount divided among all full members

2. Additional Shares

- 2.1 Participants at FIS Alpine and Nordic World Ski Championships (one quarter of 87.5%)
- 21.875% of the total Financial Support
- Calculated with the actual number of athletes who participated in the last FIS Alpine and Nordic World Ski Championships
- 2.2 Active Registered Athletes: Male and Female in each FIS Discipline on the Olympic Programme (one quarter of 87.5%)
- 21.875% of the total Financial Support
- One point per discipline and gender
- Maximum points per NSA = 12 (6 disciplines / 2 genders)
- Registered active athletes only
- The basis for the calculation is the list of athletes used to calculate the FIS Registration Fee
- 2.3 Organisation of FIS Competitions (one half of 87.5%)
- 43.75% of the total Financial Support
- To balance the fact that not all NSA's have the opportunity to organise events, a matrix for the number of competitions per discipline is used for the calculation
- There are different matrixes from discipline to discipline to balance the fact that there are more alpine events than for example ski jumping events
- The basis for the calculation is the list use for the calculation of the FIS Calendar Fee
