

FIS Doping Control activity report

2022-2023

The present report summarizes FIS' doping control activities during the 2023-24 season. This report is divided into four (4) sections, namely:

Section 2 - FIS Registered Testing Pool (RTP) & Additional Testing Pool (ATP) summary

To efficiently manage its doping control efforts, FIS has established a two-tier testing pool system.

Tier 1: FIS Registered Testing Pool (RTP) : Athletes need to provide daily Whereabout Information in accordance with the FIS Anti-Doping Rules and applicable WADA Standards.

Total amount of RTP athletes in the RTP: 276

- Cross-Country Skiing: 111
- Nordic Combined: 36
- Alpine Skiing: 87
- Ski Cross: 13
- Para Nordics: 28

- 56% of RTP athletes are male.
- 44% of RTP athletes are female.

Whereabouts failures - Total amount of Whereabouts Failures Recorded:

- Missed Tests: 11
- Filing Failures: 9

Tier 2: FIS Additional Testing Pool (ATP): For the sake of greater flexibility, FIS has defined an Additional Testing Pool, which includes athletes from whom some whereabouts information is required in order to locate and Test the Athlete Out-of-Competition.

Total amount of ATP athletes in the ATP: 97

- Nordic Combined: 1
- Ski Jumping: 25
- Freestyle Skiing: 36
- Snowboarding: 34
