FIS Development Program – Park and Pipe Training Camp, Dubai 2026

Dear Park and Pipe friends,

We are pleased to invite you to the FIS Development Program Park and Pipe Training Camp 2026, with a primary focus on Slopestyle and Street Style. The camp will take place in Dubai, UAE, and is designed to support developing Park and Pipe nations in advancing their skills and expertise – helping to propel the sport forward.

In line with our commitment to inclusivity and athlete development, we are excited to announce that all athletes, including Para Athletes, are warmly welcomed to join the camp. The training environment will be inclusive and adapted to support diverse needs, ensuring a valuable and empowering experience for everyone.

The camp will be delivered by an experienced coaching team consisting of a Snowboard Coach, and a Freeski Coach, providing participants with discipline-specific expertise and support throughout the week.

This schedule serves as a guideline: adjustments may be made considering the situation at hand.

Eligibility:

- Each NSA with **1 or 2** votes may register:
 - 1 female and 1 male Park and Pipe athlete, and 1 coach*
 - 1 female and 1 male Para Snowboard athlete, and 1 coach*
 - Each NSA with **3** votes may register:
 - 1 female and 1 male Para Snowboard athlete and 1 coach*
- * (please be aware that coaches are not the athletes' parents or accompanying persons)
- Athletes must:
 - be born between 1st January 2009 - 31st December 2013 (Junior World Championships age group) (exceptions may be made for Para athletes).
 - have an active FIS Code

- o have the required Equipment for Park and Pipe training
 - o have performed at local-level competitions and have the ability to jump at least 5 meters and ride a 4-meter rail
- All participants must:
 - o Sign the **FIS Development Camp declaration** in advance of the camp.
 - o Be entered by the NSA via the registration link provided.

**as FIS is pursuing gender equity in all aspects and layers of our sports, we kindly ask nations to look at the possibility of sending female coaches.*

Equipment

Athletes and Coaches must bring with them equipment, including snow gear, boards, skis, boots, helmets for Coaches and Athletes, and other protection, as well as clothing for dry-land training, and, if wished, a skateboard. **Helmets are compulsory. Athletes and Coaches must have the required equipment to join any training.**

The Equipment will be controlled on the arrival day of the Camp. If something is missing, the participant must buy or rent the equipment at their own cost. If the participant is not willing to follow the rules, he will be excluded from the camp, and the National Ski Federation will have to pay the costs for the Camp.

*Cancellations must be made within 48 hours of receiving the confirmation of participation. After this deadline, the full camp fee will be charged. Please refer to the General Information and Application Policy on the Development Hub for more details.

Insurance

All participants must have adequate medical and accident insurance. Please bring a copy of your insurance policy with you to the camp in case of an emergency.

Registration

Participation is limited to 24 participants. Registration is on a first-come, first-served basis for eligible participants.

All registered participants are obliged to attend the whole period of the Training Camp. If he/she does not do so, they will not be allowed to participate in future Training Camps organised by FIS (except in case of injury). The camp coordinator and coaches reserve the right to send any athlete who needs to meet the necessary level for training home early.

Please complete a separate Registration Form for each athlete or coach you are registering. All NSAs who register will be notified of their participation by the latest one week after the Deadline.

Postponement or cancellation of the Camp

In the event of camp postponement or cancellation, FIS will promptly notify all registered participants. However, FIS is not liable for any costs incurred by NSAs as a result.

Additional information for Coaches

Coaches participating in the camp are expected to set an exemplary standard for athletes. They must ensure they have the full required equipment and wear it correctly throughout training sessions. Coaches will also undergo specialized training and adhere to the instructions provided by our camp experts to minimize the risk of accidents. Additionally, coaches should not engage in training runs alongside athletes. If a coach or an athlete does not follow the instructions and guidance of the camp experts, they have the possibility to stop the training of the athletes or, in worse cases, to inform the NSA to ban the participant from the Camp. In this case, the NSA must pay the cost of the camp.
