RULES OF THE FIS POINTS - Edition 2024

These Rules are an integral part of the ICR.

1. The Competition

1.1 Requirements

Only races that meet the following requirements will be taken into consideration for FIS points:

- Announcement of the competition in the FIS Calendar
- Strict observance of the International Competition Rules (ICR).
- The competition must be held within the period specified in art. 3.

1.2 Schedule Changes, Shifting and Cancellation

Changes in schedule, i.e. shifting the race to another date, cancellation of competition, or essential changes in the race program must be communicated at once to the FIS

- Technical Delegate (TD) assigned to the competition.

Notice of the change must be provided to the FIS a minimum of 4 days before the first team captains meeting!

A FIS – Races

1.3.1 Slalom, Giant Slalom, Super G

In Slalom and Giant Slalom (overall result of both runs) and Super G all ranked competitors will receive FIS points.

1.3.2 Super Combined

The combination consists of a run Super G and a Slalom run. Only competitors who are ranked in both races will receive FIS points.

It is possible to assign the Super G an own codex.

All competitors ranked in the Super G get FIS points.

1.3.3 If the Slalom will be organised before the Downhill or Super G and the competitors with status DNS, DNF or DSQ in Slalom would like to start in Downhill or Super G, they have to start with their original start bib after the last qualified competitor from Slalom.

B FIS – World Cup

1.3.3.1 Slalom and Giant Slalom

1.3.3.2 Applies to men and women

The World Cup Slalom and Giant Slalom will be held usually in two runs.

The best 30 men and 15 women from the first run are starting in the second run. All ranked participants of both runs will receive World Cup points (time limit 20%) and FIS points.

1.3.3.3 Super G

1.3.3.4 FIS points

All ranked competitors will receive FIS points. In addition the first 15 classified women and the first 30 classified men will receive World Cup points (time limit 20%).

1.3.4 Super Combined

The combination consists of one run Super G and one run Slalom. Only those participants who are ranked in both competitions will earn FIS points.

The first 15 classified women and the first 30 classified men, who are ranked in the Super Combined are given World Cup points (time limit 20%).

There is the possibility to give the Super G an own codex. This would enable all competitors, who are ranked in Super G to get FIS points.

1.4 Competitions for Juniors

At FIS Calendar competitions for juniors (NJR or JUN) seniors are not allowed to participate. Exception: National Junior Championships.

1.4.1 Change of JUN competitions

If a National Ski Association wishes to change a competition originally registered as a Junior (JUN) competition (due to lack of junior entries for example) to a FIS race and therefore enable seniors to earn FIS points, then such a change must be announced to the FIS office at least 10 days before the competition.

1.5 National Championships

For each National Association's national championships only one race per sex in each event is allowed for women and men with the relevant category adder for NC and NJC.

2. The Competitors

2.1 Registration

- Competitors are registered by using the FOU System on the FIS website via the Member Section, <http://www.fis-ski.com/>. Change the status "active" to "inactive" for all those competitors who should not be included on the FIS points list anymore. Competitors with the status "active" will be considered as registered for the coming season.
- All competitors who reached the 15th birthday before the end of the calendar year (Art. 607 of the ICR) will be considered.
- Only competitors who have signed the athletes declaration as per ICR art. 203.3 may be registered for a FIS licence.
The National Ski Association is responsible that they have appropriate insurance and have signed the FIS athlete's declaration.
- Active (in the FIS points list). The status "active" remains also if athletes do not participate at a FIS event. Status changes from "active" to "inactive" can be done from 1st January until 30th June.
- Only competitors with an active FIS code are allowed to participate in FIS events. Entries are controlled by the Organiser and the FIS Technical Delegate.

2.1.1 FIS Code Number

Only competitors (women and men) with a valid FIS code are admitted to the FIS races.

3. Evaluation Period

3.1 Northern Hemisphere

The evaluation period starts 1st May and ends 15th October.

3.2 Southern Hemisphere

For the Southern Hemisphere, the evaluation period starts 1st November and ends 15th April.

4. Calculation Process

4.1 Race Points

The race points will be calculated according to the Grasski formula (see page 20).

4.2 FIS Points

4.2.1 Base FIS Points list (BL) (*)

The Base FIS Points List (BL) will be published end of March.

4.2.1.1 The average of the best two results

The average of the best two results in each event during the past season will be used for the calculation of the BL list.

4.2.1.2 Only one result

For a competitor who has obtained only one result in any of the events Downhill, Slalom, Giant Slalom, Super G or Super Combined, during the past season period, a 20% (+) of their result will be added to the result.

4.2.1.3 No result

For a competitor who has not obtained any results in any of the events Downhill, Slalom, Giant Slalom, Super G or Super Combined, during the past season period, a 50% (>) will be added to the previous BL points.

4.2.1.4. Injury status – Registration

In case of injury the National Ski Association must apply to FIS as soon as possible or latest until 28th February for approval submitting the official form and a medical certificate to FIS. This official form and medical certificate are only valid for one season.

4.2.1.5 Injury status – Conditions

- At least 8 months must have been passed between the time of the injury and the competitors 1st start.
- Competitors must remain registered as active with the FIS to maintain injury protection.

A competitor has not started more than two (2) times in one event and/or six (6) times across all events during the valid season 10% (#) will be added to the competitor's BL if the current points are not better as the protected points.

4.2.2 Normal FIS Points list (NL)

The 1. FIS Points list will be published on 4th May based on the BL.

4.2.2.1 The NL will reflect the average of a competitor's best two results in each event during the current period if the points are better as the BL.

- 4.2.2.2 Only one result and no BL points
20% will be added to the competitor's result.
- 4.2.2.3 Only one result and BL points
If the competitor has only 1 result per event during the current periode, but has BL points, than the BL points will count.
- 4.2.2.4 Competitors who are no longer active
After two years without results the FIS points will be specially marked on the FIS points list (see also art. 5.2).
- 4.2.4 Validity Period
The validity period of the results is the current season.
- 4.2.5 Anti-Doping rule violation
An athlete subject to an anti-doping rule violation will have previously achieved FIS points deleted, according to article 10.1.2 FIS Anti-Doping Rules.
- 4.4 Calculating penalties**
- 4.4.1 Calculation of the penalties
The penalty calculation shall be based on the corresponding valid lists.
- 4.4.2 The best five competitors who started the race
The five competitors with the best FIS points who started the race, are selected (classified, disqualified, DNF and did not start 2nd run). The competitors with status "DNS1" will not be considered. If the points are above the maximum value, the maximum value will be used.
- 4.4.3 The best five classified competitors
The five competitors with the best FIS points who are ranked amongst the top ten of the race concerned will be selected.
If points are above the maximum value or missing, the maximum value will be used for the penalty calculation.
- 4.4.4 Less than five Competitors: maximum value
If there are less than five competitors with FIS points amongst the first ten of the result list, or there are not five competitors who started with FIS points, then those competitors without FIS points, i.e. the remaining competitors will receive the maximum value:

- If less than three competitors with FIS points are ranked within the five, which are taken into consideration, the competition is not considered. At least three competitors must have FIS points (irrespective of the number of points) and at least five competitors have to be classified.
- 4.4.5 Two or more competitors are ranked 10th
In the event where two or more competitors are ranked 10th in the race, they shall all be taken into consideration for the penalty calculation, as long as they are included in the five with the best FIS points.
- 4.4.6 Two or more competitors have the fifth best FIS points

If two or more competitors have the fifth best FIS points, which should be taken into consideration for the penalty calculation, the competitor with the higher race points will be considered for the penalty calculation (reason: better penalty).

4.4.7 Calculation

- The best five FIS points or the maximum value of the first ten classified competitors (= sum A), and the best five competitors who started in the FIS points ranking (= sum B) are added. Now the race points of the competitors with the best five FIS points are added (= sum C). The maximum value of the race points will be calculated if they are higher than the maximum of the corresponding competition (DH 310, SL 145, GS 200, SG 250, SC 250).
- Now the sum of the race points will be subtracted from the sum of the best five FIS points of the ten classified and the best five competitors who started.
- The resulting figure shall then be divided by ten (sum A + sum B – sum C):10)

4.4.8 Rounding up and down the penalties

The points shall be rounded down from four thousandths of a point downwards and rounded up from five thousandths of a point upward (e.g. 13.654 = 13.65 or 21.849 = 21.85).

4.5 Category minimum/maximum-value

The category adder and minimum/maximum values will be published on FIS website.

5. The FIS points list

5.1 The FIS points list is only available electronically

On the FIS Website (<http://data.fis-ski.com/grass-skiing/fis-points-lists.html>) the FIS points list can be downloaded as Zip, Excel and CSV file.

The Zip file GSFPxxx.zip is published which (the “xxx” is always the number of the list and season - for example 1st List 2018 = GSFP118F.zip = full list or GSFP118P = only updated information since last list).

5.2 Identification

- * Base List
- # Injury Status protection according art. 4.2.1.4 and 4.2.1.5
- + competitors who have only one result in that event during the past season according art. 4.2.1.2 (20%)
- > Competitors who have not obtained results in that event during the past season according art 4.2.1.3 (50%)
- Injured with real points
- r Competitors who are no longer active (after two years without results)

6. Printing deadlines and validity of the individual lists

The printing deadlines and validity date are published on the FIS website.

7 Registration fee

7.1 Registration

The registration fee for each registered competitor is CHF 33.--. This amount will be debited from the FIS current account of the respective National Ski Association.

7.2 Registration fee per season for each competitor

A registration fee for each registered competitor will be charged. This amount will be debited from the FIS account of the respective National Ski Association. See Rules for the FIS Calendar and Registration Fees.

7.3 No refund

If a competitor retires during the season or there is an incorrect registration made by the National Ski Association, no refund will be made.

8. Instructions for organisers and Technical Delegates

8.1 Electronic data transmission

The results must be transmitted just after the races electronically and in the FIS format (E-Mail: alpineresults@fisski.com). The TD must supervise the correct transmission of the results and make a corresponding report online immediately after the event and check if the results on the FIS website are correct.

Results without TD online report and Technical Timing report will not be included in the FIS points list.

For results which are not sent electronically in the FIS format close to the printing deadline, there can be no guarantee given that the results will be published in the following FIS list even if they are sent on time.

8.1.1 Composition of the file name for the transmission of race results:

- Nation of OC (three letters as listed in the FIS ICR)
- Codex (according to the FIS calendar)
- After the point: - xml (for example: AUT3069.xml)

8.2 Recommendation for evaluation or non-evaluation

Should there be valid reasons to exclude the competition from being evaluated for FIS points, these reasons must be indicated on the "Report of the Technical Delegate".

If a race has to be cancelled after a large number of racers have finished; the Technical Delegate must submit a report with a recommendation for evaluation or non-evaluation of the race.




