EXCERPT - RULES FIS CROSS-COUNTRY WORLD CUP 2023-2024

World Cup Entry Requirements

Basic entry requirements

The quota is valid under the condition that every individual competitor has an active FIS code number and scored in the valid FIS Points List:

Sprint World Cup:

150 FIS Points or less on the FIS Points list (distance or sprint) valid for the respective World Cup

Distance World Cup:

150 Distance FIS Points and less on the FIS Points List valid for the respective World Cup

Exception for the NSA's not carrying out a FIS World Cup

Each FIS affiliated National Ski Association not carrying out a FIS World Cup can register one (1) competitor per gender in the Distance competition if:

- they have scored 150 FIS Points (distance or sprint) on the FIS Points List valid for the respective World Cup.
- or
- One (1) result equal or better than 100 FIS points (distance or sprint) at the U23 WSC or JWSC, WSC in the previous or current season.

Valid FIS points lists see article 2.1.1.

2.2.4 Extra quota for COC leaders or winners

The Overall winners from the previous season's COC have the right to start in the 1st World Cup period in the following season.

The leaders (women and men) of all COC Cups at the following dates have the right to start in World Cup competitions during the next World Cup period:

The leaders (women and men) of all COC Cups at the following dates have the right to start in World Cup competitions during the next World Cup period:

1 st World Cup Period 2023-2024	COC Winners season 2022/23
2 nd World Cup Period 2023-2024	Leaders on 25 th December 2023
3 rd World Cup Period 2023-2024	Leaders on 15 th January 2024
4 th World Cup Period 2023-2024	Leaders on 20 th February 2024

A valid list of these qualified athletes will be published on the FIS website.

Each COC Coordinator is responsible to send the names of the qualified athletes to the FIS Nordic Office (directly to: nordics@fis-ski.com) according to the following deadlines:

1 st World Cup Period 2023-2024	1 st November 2023
2 nd World Cup Period 2023-2024	25 th December 2023
3 rd World Cup Period 2023-2024	15 th January 2024
4 th World Cup Period 2023-2024	20 th February 2024

These additional quotas are nominative, the athletes cannot be substituted if they cannot start due to force majeure.

The athletes must reach the World Cup entry requirements (see art. 2.1).

The winners or the current leaders (1 person per gender) of all listed COC will get reimbursement according to art. 6.

In case of a tie, the spot will be awarded according to the following principle: If two or more competitors score the same number of points, the spot will be given to the competitor who has:

- a) the highest number of individual COC wins
- b) the best results (e.g. most 2nd places, most 3rd places, etc.)

If the competitors are still equal, they will all get an additional quota.
