

# FIS Para Alpine Skiing and Para Snowboard Classifier Training and Certification Pathway

(Version: February 2024)

## What is a Classifier?

A Classifier is a person authorised as an official and certified by the International Ski and Snowboard Federation (FIS) to evaluate Athletes as a member of a Classification Panel.

Para Alpine Skiing and Para Snowboard Classifiers are medical professionals, all of whom have the competencies and qualifications relevant to conduct all, or specific parts, of Athlete Evaluation in accordance with the FIS Para Alpine Skiing or Para Snowboard Classification Rules and Regulations. Para Alpine Skiing and Para Snowboard Classifiers follow the same training pathway and are dually certified to classify in each sport.

A Classification Panel consists of two Classifiers. A Classifier's role is:

- to conduct Eligible Impairment Assessments and/or Minimum Impairment Criteria Assessments;
- to apply the assessment methods established in the FIS Para Alpine Skiing or Para Snowboard Classification rules properly and consistently; and
- if required, to conduct the Observation Assessment in cooperation with other members of the Classification Panel.

## Classifier Profile

All Classifiers must have:

- a thorough understanding of Para Alpine Skiing and Para Snowboard and the sports rules, including, but not limited to, the International Competition Rules (ICR), Classification Rules and Regulations, and the Equipment Specifications for Para Snowsports;
- a thorough understanding the IPC Athlete Classification Code and International Standards and the FIS Code of Ethics;
- a medical qualification as a physician who has experience in dealing with Underlying Health Conditions that may lead to an Eligible Impairment catered for by Para Alpine Skiing and Para Snowboard; or
- a physiotherapy qualification or other related disciplines with experience of individuals with the clinical manifestations of the Eligible Impairments catered for by Para Alpine Skiing and Para Snowboard;
- a requisite level of anatomical, biomechanical and sport-specific expertise in the sport of (adaptive) Alpine Skiing and Snowboarding; and
- business level written and spoken English.

## Classifier Pathway

The FIS Para Alpine Skiing and Para Snowboard Classifier Pathway consists of four stages:

1. Completion of the [IPC Classification Fundamentals online course](#) (and relevant medical qualification) → Classifier Candidate
2. Successful completion of a Classifier Seminar → Classifier Trainee
3. Successful completion of at least two supervised International Classification Opportunities\* → FIS International Classifier
4. Maintenance of FIS International Classifier License

Stage 1: The IPC Classification Fundamentals online course is open to anyone interested in learning more about Classification. It is also a pre-requisite for those intending to follow the pathway to become a Classifier Trainee or an International Classifier. Only those who hold a relevant qualification may be recognised as a Classifier Candidate and eligible to participate in a Classifier Seminar (exceptions may be made for those who only intend on classifying on the national level).

Stage 2: The Classifier Seminar is delivered as either a face-to-face course (usually three days) or as part of a series of online seminars. Upon successful completion of the Classifier Seminar, the participant will be certified as a Classifier Trainee and is expected to have the knowledge and competencies required to carry out national Classification. The status National Classifier is at the discretion of the Classifier Trainees respective National Ski or Snowboard Association (NSA).

Stage 3: Classifier Trainees wishing to continue along the pathway to become an International Classifier must attend at least two International Classification opportunities\* within three seasons of attending the Classifier Seminar. Classifier Trainees may participate in some or all the components of Classification under the supervision of a Classification Panel to develop the necessary Classifier competencies to achieve certification.

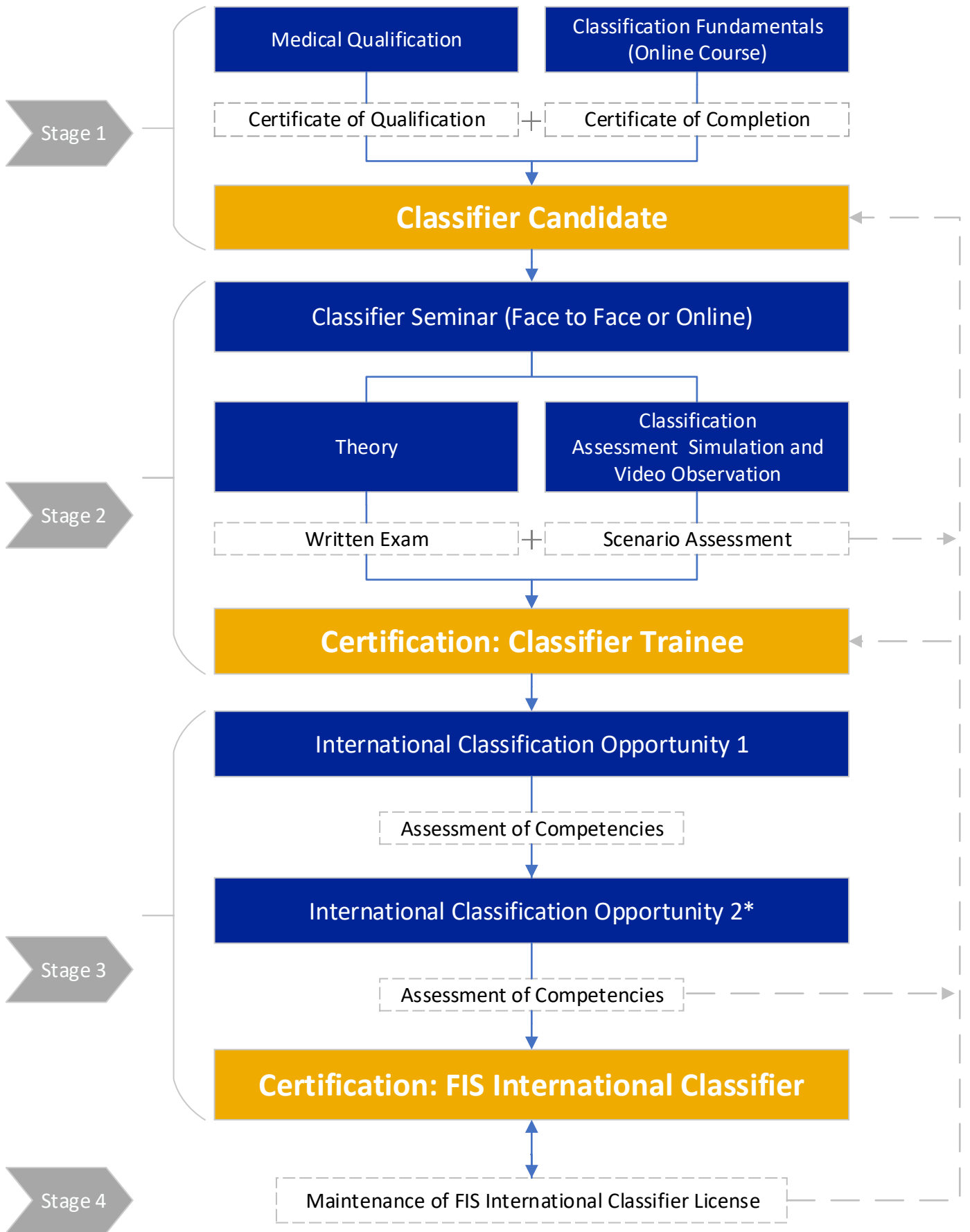
\*In exceptional circumstances, Classifier Trainees who show exceptional competencies may be certified after one International Classification opportunity (e.g. an experienced International Classifier of another sport).

Stage 4: Upon certification, International Classifiers must remain active and engaged and continue to demonstrate the required Classifier competencies to maintain their license.

More information about each of the stages can be found below the Classifier Pathway diagram.

For the avoidance of doubt, all costs related to Classifier training or recertification is the responsibility of the candidate.

Note: This Classifier pathway does not address Classification for athletes with Vision Impairment(s). A specific programme exists in joint cooperation with the International Paralympic Committee (IPC) and International Blind Sport Association (IBSA).

### Stage 3: Steps to becoming an International Classifier

Entry Requirements	<ul style="list-style-type: none"> <li>• Certification as a Classifier Trainee</li> <li>• Intermediate to good skier/snowboarder</li> <li>• Must have no conflict of interest (see below definition of Conflict of Interest)</li> </ul>
Participation	<ul style="list-style-type: none"> <li>• At least two separate FIS Para Alpine Skiing or Para Snowboard International Classification opportunities (Exceptions may be made for those who show exceptional competencies and who may be certified after one international Classification opportunity. E.g. an experienced International Classifier of another sport).</li> </ul>
Delivery Method(s)	<ul style="list-style-type: none"> <li>• Observation of Classification assessments by a Classification Panel, including paperwork, communication, athlete assessment, decision making</li> <li>• Conduct Sport Class Assessments under supervision, including completion of Classification Form(s)</li> <li>• Observation on snow of the classified athletes</li> <li>• Participate in all other Classifier activities, e.g., attending pre-event Classification meetings/post event feedback sessions</li> </ul>
Learning Objectives (including, but not limited to)	<ul style="list-style-type: none"> <li>• Know the role of Classifier</li> <li>• Understand and apply the conceptual basis of Classification to a high standard</li> <li>• Know the Minimum Impairment Criteria (MIC) for each Impairment Type and where to locate it within the FIS Para Alpine Skiing and Para Snowboard Classification Rules and Regulations accurately and efficiently</li> <li>• Know and be able to complete all relevant assessment methods (medical or technical) for athletes with a Physical Impairment to a high standard of validity and reliability</li> <li>• Know how to conduct Observation Assessment to a high standard</li> <li>• Know how to properly communicate Classification outcomes accurately and efficiently</li> <li>• Understand and demonstrate leadership in the management of risks in Classification</li> <li>• Ability to complete all relevant paperwork accurately and efficiently</li> </ul>
Assessments	<ul style="list-style-type: none"> <li>• Assessment by competency transcript</li> </ul>
Outcomes	<ul style="list-style-type: none"> <li>• Successful Classifier Trainees will receive a FIS Para Alpine Skiing and Para Snowboard International Classifier certification; and</li> <li>• Be licensed (pending maintenance of license) and eligible for appointment as an International Classifier at FIS International Classification opportunities.</li> <li>• Classifier Trainees not yet meeting the required Classifier competencies may be required to redo all or some parts of the Classifier Pathway prior to certification.</li> </ul>

## Stage 4: Maintaining License as an International Classifier

To maintain an International Classifier License, a Classifier must:

- Classify at least once every two seasons at an International Classification opportunity;
- Attend annual Classifier Updates; and
- Actively participate in workshops or recertification seminars at the discretion of FIS.

Classifiers may be required to return to any stage of the Classifier Pathway due to inactivity or if Classifier competencies are not maintained.

### Obtaining a license after a period of inactivity (more than two seasons)

The recertification process is dependent on the Classifier's experience before the period of inactivity and any Classification activities performed during their inactivity.

Inactive Classifiers must provide the FIS Para Alpine Skiing and Para Snowboard Head of Classification (HoC) with reason of absence. The decision on the recertification pathway will be at the discretion of the HoC and FIS.

After longer periods of inactivity, the inactive Classifier may go through the Classifier pathway once again, starting with the Classifier Seminar.

### Conflict of Interest

There is an objectively high risk of an actual, perceived, or potential Conflict of Interest arising in circumstances where a person has (or has recently had) a close association or role with an NSA is also involved in Classification.

As such, anyone who holds a position on their national team in a management role or as a physician/physiotherapist or coach/trainer may participate in a Classifier Seminar for the purpose of learning how to classify athletes on a national level but may not proceed past the stage of Classifier Trainee until they no longer hold that position within their team.

### Classifier Seminars

FIS will organise a Classifier Seminar at least biannually. NSAs may also request FIS to host Classifier Seminars for the purpose of training National Classifiers at the expense of the NSA.
