#### Your main Responsibilities:

- Coordinate the planning and preparation of the Para Snowsports Classification calendar in collaboration with the Para Snowsports Coordinators.
- Assist Organisers and other stakeholders prior to, during and after Classification, on and off site.
- Maintain the FIS Para Snowsports Data Management System (FPDMS), FIS Classification Master List, FIS Classification website.
- Conduct all administrative activities in connection with Classification,
- Independent handling of correspondence with NSAs, OCs, etc.
- Communicate regularly with Heads of Classification for Para Alpine Skiing, Para Snowboard and Para Nordic on Classification initiatives.
- Administration of the Para Snowsport Classification Expert Group,
- Communicate and manage relationships with researchers and research centres.
- Manage communication with the International Paralympic Committee and the Classification Department,
- Preparation and coordination of Classification seminars and training courses for Para Snowsports Classifiers,
- Assist in developing and maintaining classification documents (e.g. Rules and Regulations, Classification Forms, guidelines etc.)
- Ensure compliance with the IPC Classification Code
- Administer all official communications of FIS in relation to classification with the NSAs, Organisers and other stakeholders.
- Coordination of the Para Snowsport Classifiers
- Monitoring Classification activities in collaboration with the Heads of Classification
- Preparation of meetings, invitations, presentations, minutes, proposals for the Executive Board/Council etc.,
- Assist in the planning and delivery of Paralympic Winter Games and Para World Championships
