## The International Snowboard / Freestyle / Freeski Competition Rules (ICR)

### 2008.7 Expense Accounts

Technical Delegates\* (and the Referee when appointed by FIS) have the right to reimbursement for their travel expenses up to a maximum of CHF 600.--<sup>1</sup> For longer distances (train, first class or air fare, tourist class) or car per kilometer, CHF 0.70 or equivalent which amount included any applicable highway taxes. The TD is entitled to receive free accommodation and meals during the assignment. This rule also applies to inspections.

In addition, a fixed daily rate of CHF 125.100--\* for World Cup, Continental Cup and World Championships and CHF 100.-- for lower level events is added for the travel days to and from, as well as each day of the assignment, which includes postage charges for mailing reports, etc. Double charges (e.g. travelling home on the same day as the last competition) is not permitted. If overnight accommodation during the journey to and from the assignment is necessary such expense shall be justified and reimbursed separately.

#### Forerunners

##### 2012.4

~~Competitors disqualified in the first run or phase are not permitted to start as forerunners in the second run.~~ Competitors suspended for disciplinary reasons cannot be named as forerunners.

##### 2014.7

#### Age for International Juniors including Junior World Ski/Snowboard Championships

##### Minimum age

The minimum age's for ~~Halfpipe, Slopestyle and Big Air are according to 2014.2. For Parallel and Snowboard Cross 2014.3 applies. For Aerials and Moguls/Dual Moguls 2014.5 applies and for Ski Cross according to 2014.4 above all Junior competitions are the same as for participation in International competitions that are not Major Events. See 2014.2 to 2014.5 above.~~

##### Maximum age:

PGS, PSL, SBX and Team SBX: Competitors who have reached ~~their~~ 19th birthday before the end of the calendar year in which the FIS competition year begins.

BA, HP and SS: Competitors who have reached ~~their~~ 17<sup>th</sup> birthday before the end of the calendar year in which the FIS competition year begins.

For AE and MO/DM: Competitors who have reached ~~their~~ 19<sup>th</sup> birthday before the end of the calendar year in which the FIS competition year begins.

For SX: Competitors who have reached their 20<sup>th</sup> birthday before the end of the calendar year in which the FIS competition year begins.

## 3311.4 Development

The development for a Judge is:

- Obtain a C Licence [from Nation via the official certification path](#)
- Gain Regional/National judging experience
- Attend an International Judging Clinic.
- Satisfactory completion of steno/written exam at an International Clinic.
- If prerequisite for judging experience is met, the judge is eligible to obtain an international Licence. (See 3311.6 Qualifications – Licence)

### **3311.5**

#### **Training**

For Snowboard initial training of the applicant is done via the NSA using platforms such as WSF education process and open to all judges.

For Freeski, it is the responsibility of each National Association. the responsibility of each National Association.

### **3311.6.3**

#### *Prerequisite for a C-Licence*

C-LicenceFor Snowboard, the C-is a National Licence is issued by the FIS JAG using WSF and requiring standardized online training, a live clinic (in person or remote) and standardized online testing.

For Freeski, it is a National Licence and is based on the NSA's rules and structure. FIS SB & FK JAG will maintain a current list of C-licensed judges submitted to the JAG by the NSAs.

### **3311.6.4**

#### *In General*

For Snowboard, C level licences will be given out by the FIS JAG / WSF following an agreed certification protocol between FIS and WSF.

A Nation can only issue a C-Licence. In order to obtain a higher Licence, a judge needs to attend an International FIS judging Clinic and be approved by the FIS SB & FK JAG.

### **3311.11**

#### **Expense Accounts**

Judges are entitled to reimbursement for travel expenses up to CHF 600.—<sup>1\*</sup> (highway taxes included)<sup>1</sup>, as well as free accommodation and meals during their assignment. This rule applies to inspections as well as the trip to the competition (first class rail or, for longer distance, tourist class air fare, or car at CHF 0.70/km). Judges receive in addition a fixed daily rate of CHF 125.00\* for World Cup, Continental Cup and World Championships and CHF 100.-- for lower level events for travel days to and from, as well as each day of the assignment.

The Head Judge may receive 1 additional day on assignment, and expense up to 10 CHF/day for use of a personal cell phone at international events.

Double charges (e.g. when travelling home on the same day as the last competition) are not permitted. If overnight accommodation during the journey to and from the assignment is necessary, it must be justified and reimbursed separately.

On training day, if a judge has further than 200 km drive to the competition, accommodation must be provided the preceding night by OC unless official training starts after 10:00 am.

If there is night/evening finals and competition ends later than 20:00, accommodation must be provided by OC prior to the judges departure.

The judges must attend one day of training at the CoC level.

### **3311.11.1**

#### **Payment of Judges' Per Diems and Expenses**

The payment of the CHF/USD/EUR must be paid electronically by bank transfer no later than fifteen (15) business days after the last competition or when Judges have sent in their Expense sheet to FIS/LOC.

A late payment charge of CHF 300 will apply for FIS/LOC from 15 business days after the last competition day or receiving the bank information for each late payment to each individual judge.

After 30 business days, a 2<sup>nd</sup> charge of CHF 300 will apply until payments are done. After 45 business days, a 3<sup>rd</sup> charge of CHF 300 will apply until payments are done.

Excluded from this is a delay due to wrong or missing bank account information as provided by the Judge.

The judge is responsible for transmitting their bank account information including all necessary data (official form is available on the FIS Website) electronically to the FIS/LOC. The date of submission of bank details to the FIS/LOC is valid for the above deadlines for the FIS/LOC to execute payment.

### **3403**

#### **Point System**

Each Judge shall give a score out of 04-100 to each competitor, without the use of decimals. Wherever the competitor's score is derived from a calculation involving division, the result shall be truncated (rounded down) and shown to two decimal places.

### **3403.3**

#### **Section by Section Judging for Slopestyle (SS)**

Overall Judges will enter 40-100 points each and Trick Judges will enter 40 -100 points each and this will be recalculated in the Data & Results system.

### **3604.1.1**

#### **Start Order OWG, WSC, WC**

The competitors of each heat will be divided into 2 Groups and drawn separately for the starting order.

Group 1: Competitors seeding ranked 1 - 106<sup>th</sup> upwards in the each heat.

Group 2: Competitors ranked 1<sup>st</sup> st to 5<sup>th</sup> onwards in each heat.

It will be announced at the TC meeting whether group 1 or 2 starts first. Additionally, if a competitor gets drawn first in 2 consecutive events the Team captain can ask for a redraw.

### **3604.3.1**

#### **Start Order in Big Air Final (2 best of 3 runs format or 1 best of 2 runs)**

Start order for Finals will be the same for the first 2 Final runs based on results from Qualifications and Semifinals. The 3rd and last run shall be conducted by ordering the finalist in a reverse order according to the Ranking after final run 2.

In the event that a 2 run final is conducted, the second and last run can be conducted by ordering the finalist in a reverse order according to the ranking after Final run 1.

In both cases, if the scores are the same, the worse seeding position decides who starts 1st.

## **Did not Finish (DNF)**

DNF shall be imposed for any run in which the competitor starts but does not finish. A competitor who is marked DNF classification in all rounds of the qualification phase will receive and be listed with no rank on the result list. Not be ranked and shall not proceed to the next phase. A competitor who is marked DNF in a subsequent phase shall be ranked in accordance with the rules for the specific Event.

When competitors receive a did not finish (DNF) and are not ranked, they will not be permitted to start (NPS) in the next phase.

All decisions concerning DNF will be the responsibility of the Jury.

## **Formats Overview**

### **Aerials**

**4104.2.1**

In Aerials, several formats may be used: the Final World Cup, the Championship or the Standard, the Short or the Championship. There are two options for the Final phases in the Final format.

**4104.3**

### Final Format World Cup Format

In the Final format, all competitors shall compete in a Qualification phase consisting of one or more rounds. There can be two options for the Final phase. In the first option, after the Qualification phases, the top 12 Women and top 12 Men shall advance to the Final phases. The finalists will take one additional jump and these results shall be added to those from the first phase. The remainder of the field will be ranked according to the results in the Qualification phase. In the Final phase, the competitors shall run in reverse order of the placing in the Qualification phase.

In the second option, the top 8 competitors from the Qualification will be seeded into the Final, which will consist of a series of elimination heats, semifinal phases and Final phases.

In each phase, there is a series of heats with a pairing of two competitors. The start order of the Final phase will be based upon the Qualification results and the results of each heat. The winner of each heat will advance into the next phase and eventually the winner will be determined in the Final heat.

In each heat, the competitor with the higher score will advance to the next phase and be paired against a competitor from other heats based upon a ladder.

The World Cup format is to be used at all FIS World Cup competitions.

**4104.3.1**

The World Cup format comprises:

- a Qualification Phase (Q) consisting of one round
- two Final Phases (F1, F2) each consisting of one round.

**4104.3.2**

Competitors ranked down to 12<sup>th</sup> place in the Qualification Phase shall proceed to F1.

**4104.3.3**

Competitors ranked down to 6<sup>th</sup> place in F1 shall proceed to F2.

#### 4104.3.4

#### *Repetition of Aerials manoeuvres*

For the purposes only of 4115.3 (repetition of Aerials manoeuvres), F1 and F2 are considered as a single Phase

#### 4104.4

#### **Standard Format**

~~In the Standard format, a decreasing number of competitors will proceed into the next rounds and phases. If the second phase cannot be completed then the results from the first phase will be valid.~~

~~There can be more than one round in the Qualification (Q) and Final (F) phases. In each round there will be one jump.~~

##### **Qualification Phase**

~~If only one Qualification round is to be run, all the competitors in the Final shall be determined from the results of that Qualification round. If a second Qualification round (Q2) is to be run, half the field for the Final shall be filled from the highest ranked in the first round (Q1); then a second Qualification round (Q2) shall be run. The ranking after Q2 is based upon the better score from Q1 or Q2.~~

##### **Final Phase**

~~In the Final phase, there can be two or three rounds depending on the level of the competition. The top ranked competitors from the Qualification phase will compete in the Finals phase.~~

~~If two rounds (F1/F2) are held, a limited number of the highest ranked competitors in F1 will compete in F2 to determine the final result.~~

~~If three rounds (F1/F2/F3) are held, a limited number of the highest ranked competitors from F1 and F2 will proceed to F3. In this case, the better score from F1 or F2 will be used to seed a limited number of competitors into F3, which will determine the final result. The numbers that are to compete in the various phases and rounds at different levels of competition are defined by the following table:~~

#### 4104.5

#### **Short Format**

~~In the Short Format, there shall be no Qualification phase and each competitor shall make two jumps in the Finals. The competitor's score is the sum of the scores of both jumps. This format is not to be used at World Cup or Major Competitions. In the Short Format, if the competition is halted after the first round of jumps, the results from that round shall constitute the final results for the competition.~~

#### 4104.64

#### **Championship Format**

~~In the Championship format, all competitors shall compete in a Qualification phase consisting of two rounds. The qualified competitors as specified in rule 4124 will move to the Finals. In the Finals, the competitors shall run in reverse order of the placing in the Qualification or the results prior to F3. The remainder of the field will be ranked according to the results in the Qualification or the better score from F1 or F2. The Championship format is to be used at World Ski Championships and Olympic Winter Games.~~

#### 4104.4.1

#### **The Championship format comprises:**

A Qualification Phase consisting of two rounds (Q1, Q2)

Three Final Phases (F1, F2, F3). The number of competitors in F1 is 12 unless a tie for the last place has resulted in an expanded Final field (see 4007.3).

- 4104.4.2 Competitors ranked down to 6<sup>th</sup> place after Q1 shall proceed to F1.
- 4104.4.3 The remaining competitors shall compete in Q2. The competitors shall be ranked using their better score from Q1 and Q2.
- 4104.4.4 The number of competitors from Q2 to proceed to F1 shall be taken from those ranked highest after Q2, with any tie for the 12<sup>th</sup> place in F1 being handled by 4007.3.
- 4104.4.5 The competitors in F1 shall all compete in F2. Competitors' ranks after F2 are taken from their better score from F1 and F2.
- 4104.4.6 Competitors ranked down to 6<sup>th</sup> place shall compete in F3.
- 4104.4.7 *Repetition of Aerials manoeuvres*  
For the purposes only of 4115.3 (repetition of manoeuvres):  
for Men, F1, F2 and F3 are treated as one Phase  
for Women, F1 and F2 are treated as one Phase, and F3 as a separate Phase.

#### 4104.5 Standard format

The Standard format is to be used at all competitions where the World Cup or Championship formats are not used.

- 4104.5.1 The Standard format comprises:  
a Qualification Phase consisting of two rounds a Final Phase consisting of one round.
- 4104.5.2 The number of competitors to participate in the Final shall normally be 6 or 12, to be announced in the competition Invitation and confirmed by the Jury at the first Team Captains' Meeting.
- 4104.5.2 The competitors shall be ranked after the Qualification Phase using their better score from the two rounds. Competitors ranked down to 6<sup>th</sup> or 12<sup>th</sup> place depending on the size if the Final field (see 4104.5.2) shall compete in the Final.

#### 4104.7 Major Competition Format

World Ski Championships and Olympic Winter Games shall use the Championship format.

~~If either a Championship format Qualifications and Finals or two different Standard or Final competitions are scheduled, they may be held over two days (e.g.: Qualifications on one day, Finals on another day).~~

- 4110.4.3.2 If any ties remain, the competitor with the better Air&Form score will receive the better rank.
- 4110.4.3.3 If any ties remain, the competitor with the better Landing score will receive the better rank.

- 4203.2 *Moguls*
- In the Moguls competition, all competitors will take at least one run. The qualified Women and Men, as specified in rule 4210.7 shall move to the Finals. There can be more than one round in the qualification (Q) and final (F) phases.
- Based upon the results of the qualification round (Q1), a set number of competitors will be directly seeded into the final. An optional, 2<sup>nd</sup> qualification round (Q2), based upon the ranking of the competitors remaining from Q1 will take part in Q2. In Q2 an equal number of competitors from the Q1 will be seeded into the final. The ranking after Q2 is based upon the better score from Q1 or Q2.
- In the final phase, there will can be two ~~or three~~ rounds depending on the level of competition. The top seeded competitors from the qualification phase will compete in the first round of the final (F1). A limited number of the highest ranked competitors from that round will proceed to the second round (F2). If a third final round is scheduled, the highest ranked competitors from F2 will compete in that round, otherwise, F2 becomes the final round. The numbers that are to compete in the various rounds at different levels of competition are defined by the following table.

**4210.2** **Loss of Ski(s) or Stop**

A competitor who, having started, loses one or both skis, or stops for 10 seconds or more, shall receive a ruling of Did Not Finish (DNF) for that run. The loss of other equipment, including ski pole or poles, shall not result in DNF provided that the competitor finishes.

**Dual Moguls Competition Format**

The Dual Moguls competition can be carried out using two formats. In one format, pairs of competitors compete in heats (Duals) are done from the beginning of the competition and in the other format, Duals are done in the Finals. In the second format, the qualification for the Final is done with a modified form of Moguls competition.

**4310.1** **Dual Moguls with Seeded Groups**

**4310.1.1** *Seeding for Dual Moguls*

~~Seeding which is the first phase, shall be done as follows.~~

**4310.1.1.1**

If a Moguls competition forming part of the same competition programme has been completed on the same course prior to the Dual Moguls competition, the best of the ranks from its Final Result List and current Dual Moguls series Standings (World Cup, and Continental Cups etc.) shall be used to assign competitors to positions in the Dual Moguls ladder. Otherwise, if the Dual Moguls competition forms part of a Cup series, each competitor shall be assigned a Seeding Rank equal to the better rank from the most recent FIS Points List and the series Standings.

**4310.1.1.2**

At the World Ski Championships the better rank from the Mogul Final Result List of the same venue, the FIS Points List and the Dual Moguls World Cup Standings shall be used.

**4310.1.1.3**

At the Junior World Ski Championships and for all other competitions not part of a series, the FIS Points List alone shall be used.

**4310.1.1.4**

~~In the case where series Standings as specified above are not available because of a lack of prior competition results, the FIS Points list shall be used instead.~~

**4310.1.1.5**

~~In the above procedure, in all cases where the seeding ranks are to be derived from more than one source (Moguls results, Cup Standings etc.), lists must be constructed ranking only the competitors in the Draw List, so that the ranks from each list are directly comparable; competitors without points in a given list shall be assigned a numerical rank one greater (worse) than the number of competitors entered.~~

**4310.1.1.6**

Ties shall be broken by first comparing by the Moguls Final Result ranks, then if still tied by the Cup Standings and, if still tied, then by the FIS Points List. Any competitors If still tied shall receive the same seeding rank but shall be assigned to the available start position then by random draw.

**4310.1.3**

**Assignment of Red and Blue Courses**

Round of 64 top competitor in pairing will be blue

Round of 32 top competitor in pairing will be red

Round of 16 top competitor in pairing will be blue

Round of 8 top competitor in pairing will be red

Round of 4 top competitor in pairing will be blue

Final Rounds top competitor in pairing will be red

#### 4310.2.3.32 The rankings of 1, 2, 3, 4, shall be determined by duals.

### **Did not Finish (DNF)**

The competition officials may impose a ruling entitled “Did Not Finish” (DNF) for any infractions listed below. This list does not restrict the ruling of the officials for any infraction, which may occur and is not listed below. DNF may be imposed:

**5404.1**

### **Contact causing Interference**

Contact in Cross is common. The determination of interference by one competitor against other competitor(s) shall be made by the jury. Suspected infractions can be brought to the jury's attention by acting jury members, section judges or review requested by a competitor in the finish area immediately following the heat. The jury can use recommendation from Section Judges and/or video evidence provided by coaches/staff, and/or “Video Review” from TV Production in the decision process.

From provided evidence, the jury must determine if interference has occurred. Interference shall be determined based on the articles 5404.1.1 and 5404.1.2 of the ICR. ~~Sanction described under 5404.2 for a determined interference shall be decided using the Guidelines on Intentional Contact on the FIS Website.~~

\* The minimum Eligibility requirements: according to the necessary minimum FIS points for participation in the individual PAR at the respective level of event. Furthermore all participants have to be entered as a part of their nation's regular quota for the individual competition.

### **Eligibility at the World Cup and World Championships, Olympic Winter Games**

Eligibility at the World Cup and World Championships and Olympic Winter Games will be determined by the World Cup Starting List for the event instead of the FIS Points List. In case of ties their position will be decided by the sum of the FIS Points List ranks of the same athletes and, if still tied, by draw.

In case not all teams, or a nation are represented or in the WCSL World Cup Starting List, the FIS points list will be used but these teams will always be seeded after the ones using the WCSL World Cup Starting List. At the World Cup, World Championships and Olympic Winter Games the WCSL World Cup Starting List will be used for the seeding. If only one team member or none is represented or in the WCSL World Cup Starting List, the FIS Points List will be used for both competitors but the teams will always be seeded after the ones using the World Cup Starting List. Ties will be broken according to rules 6801.43, 6801.2.

## **2.2 Accommodation & Payment of expenses**

### **2.2.1 Accommodation**

#### **2.2.1.1 Organising Committees**

Lodging, food (half board) and transportation must be guaranteed at a maximum of CHF 80 per day (max. 2 people per room/2 beds) for each competitor and official. The quotas for the payment of lodging and food are calculated on the basis of the World Cup Quotas (see point 2.3.).

The organiser can offer free accommodation. In this case it is the teams' task to provide their own meals. This is only acceptable if fully furnished apartments (ie. including kitchen facilities, bed sheets, towels, etc.) are provided.

The number of competitors per country may not exceed the total quota.

There are restrictions for officials (coaches, doctors, team staff) and official accompanying persons:

~~Organisers who choose not to provide Lodging, food (half board) and transportation at a maximum of CHF 80 per day for each competitor and official are not entitled to charge participation fees.~~

### **2.2.4 Participation Fee**

A mandatory Participation Fee (competitors only) of a maximum of CHF 350 per official training and competition day will be charged to all entered competitors, based on the program in the official invitation. The invitation should clearly state the total amount to be paid by each competitor and event. The total amount cannot be more than CHF 4200 per competitor.

Double participation (e.g. HP and SS): the participation fee only has to be paid once (e.g. 2 x Training-, 1 Qualification-, 1 Final day) or respectively up to the maximum of CHF 4200.

In case the Qualification and the Finals are on the same day, the participation fee has to be paid for one day only.

Organisers who do not provide lodging, food (half board) and transportation at a maximum of CHF 80 per day for each competitor and official are entitled to charge only CHF 20 as above described.

## **2.4 Prize Money**

The Organiser must make available at least CHF 257,0500 (equivalent in Euro/US\$) per event/gender for prize money. Greater prize money is permitted, and must be equal per gender. This sum is divided between the Top 10 competitors per event/gender. The amount of prize money and its method of distribution must be communicated to FIS (Rule 1.2.10).

From each Continental Cup Standings, the highest ranked competitor (per gender and within their event) from the host Continent will be provided an additional personal quota spot that can be entered into the FIS World Cup.

**For Moguls, the overall winners will get the spot.** These competitors will be the previous season winners (northern hemisphere) and the current season leader (southern hemisphere) according to the respective Continental Cup Moguls and Aerials standings.

## **6. Prize Money**

The Organiser must make available at least CHF 257'500 (equivalent in Euro/US\$) per event/gender for prize money. For individual competitions this sum is divided between the 10 best competitors per race/gender (at PAR individual events only, where the prize money is equal to or exceeds CHF 30'000/competition/gender the payment will be down to the 16<sup>th</sup> place). Team events the prize money is CHF 275'500 minimum and it will be distributed in between the top 3 teams per competition/gender. If the competition consists of mixed teams it will be distributed by the top 3 teams. The amount of prize money and its method of distribution must be communicated to FIS (refer 1.2.10).

### EC Trophy and Medals

For HP, SS and BA a maximum of 4 best EC points results (from Europa Cup and Premium Europa Cup) are taken into consideration and will be added together to determine the EC Event Champion and ranking.

For SS and BA there is also a combined ranking of both events. A maximum of the best 4 SS results and 2 BA results (from Europa Cup and Premium Europa Cup) are taken into consideration and will be added together to determine the winner of the personal WC spot in the upcoming season (WC Rule 2.3.3).

The winners of the HP EC ranking and the combined SS/BA ranking will receive the EC Trophy. Medals are awarded to the numbers 1, 2 and 3 of these rankings.

#### Premium snowboard NorAm P&P:

Every FIS calendar year both Canada and USA are allowed to select one of their snowboard P&P events each as a Premium NorAm that meets the requirements defined in the “[Guidelines for Organisers of Premium Continental Cup P&P Competitions](#)”.

Athletes competing at the premium events will be awarded double NorAm Points.

i.e.: the winner is awarded 200 points.... the 4th Place 100 points, etc.

## NAC 10.7

### Competition / Seeding

Start Lists for all NAC Moguls and Dual Moguls competitions will follow the procedures defined in the ICR (4209, 4310).

Seeding lists for each NorAm mogul and Dual Mogul competition will be created according to the better ranking of the most recent FIS Points List and the NorAm Cup standings. Any ties shall be broken by a random draw.

#### **NAC 10.7.1 Moguls**

The qualifying phase of NorAm Mogul competitions will be seeded for the top 25 athletes (per gender). Competitors from 1 – 25 are assigned start positions randomly then the start positions for competitors 26 to “n” are randomly assigned.

Each competitor is limited to two pairs of skis on the competition day (Qualification and Final). The Organiser will mark the skis. (ICR 5902.3.1)





### Ski Boots

Ski boots are robust footwear developed especially for skiing, offering protection against jolts and bumps as well as injury from ski edges and other external causes. The ski boot encloses the foot firmly, while at the same time allowing the movement necessary for skiing techniques, in that the ankle has the room it needs to move, but at the same time allowing the transfer of every steering movement completely to the ski.

The relevant national and international guidelines and norms establish the requirements.

- Thickness of ski boot soles
- Distance between the ski boot sole and the base of the heel including all hard and soft parts ([tB – see diagram](#)):  
Women & Men: maximum 43 mm

### Competition Suits

6.1

#### Ski Cross

Ski Cross suits ~~must~~may be one or two pieces, ~~;~~; ~~pants and a separate top~~.

Suit base material shall be textile fabrics excluding rubber, neoprene, leather or vinyl like materials or fabrics. Patches of different material are allowed provided that textile fabrics shall remain, in any event, predominant.

Material shall be uniform for the entire ~~length of the leg, from waist to pant suit from top to~~ bottom. There shall be no stiffening or layering of material to create a shape or form to the pants lower cuff.

Non-protruding body protection and padding is recommended.

Protection equipment including back protector or any other padding or body armour must be worn on the body and separate from the Ski Cross competition suit (outer wear). Protection and padding must not be built into the Ski Cross suit or attached to the Ski Cross suit by a zipper, velcro or any other means.

### Section C

3.

#### Competition Clothing

~~For SBX and Snowboard Alpine, c~~ Competition suits must be two piece – pants and separate top that are separate and worn independently. ~~Firm fitting speed or downhill suits are not permitted.~~

Race Pants: clothing that extends from the waist to the ankles, belts may be worn, but must be removable. From the upper leg downwards, the pants must be visibly loose. The outer layer of the pants must not be attached to the boot in any way e.g. by elastic

Race Jackets: clothing that can be worn independently and are removable. Braces are not allowed. Jacket should overlap pants when standing. Two parts of the suit should not be able to join together, not even temporarily. Thus the presence of any zips, hook-and-loop ("Velcro") strips, buttons, hooks and eyes etc. In positions where they might be used to join the two garments together is considered violation of the rule. Bib pants are not allowed.

Non protruding body protection and padding is recommended.

~~Protective equipment i.e. back protection must be worn on the body. No straps, fastening devices or other methods can be used to tighten the suit material closer to the body. Shin guards are excluded from this rule.~~

One piece suits (Speed or downhill suits) even worn under a separate top are prohibited.

This rule does not apply to Park & Pipe events where no specific clothing rules exist.
