



# **FIS RULES AND TERMS OF REFERENCE FOR COMMITTEES**

**EDITION 2022**

## **Introduction**

The Rules (Terms of Reference) for the FIS Committees, Version VI, March 1983 was worked out on request of the FIS Council and the Working Group for Re-organisation (meetings of December 3, 1982 in Rome and of February 26, 1983 in Falun) and based on the decisions of the FIS Council Meeting in February 1982 in Oslo and the provisional drawings of the proposed re-structure of the Committees (December 4, 1982).

A revision of the regulations was undertaken in 2000 and distributed after the 42<sup>nd</sup> International Ski Congress in Melbourne since there were a number of new Committees introduced since the regulations were implemented in 1983 and additionally other Committees which no longer exist or have merged with others. Further changes to the Committees decided by the FIS Council at its meetings during the FIS Congress in Portoroz in June 2002 and some amendments to their tasks and responsibilities were updated. Adaptations have been made thereafter on a regular, evolving basis to the Committees and other Bodies such as the Athletes' Commission, including their membership and tasks.

In November 2018, the Council approved the "High Five to Gender Equality", which has established membership criteria targets for the FIS Committees that are integrated in this document (see art 5.3).

This version incorporates the amendments to the Committees until 2022.

The funnel system, which is designed to improve the working methods and communication of the various Committees, is also recognised in the structure of the Committees, Sub-Committees and Working Groups.

## **PART A**

### **The FIS Statutes**

- 1** The Council appoints the Chairs and the Members of Committees, Sub-Committees and Working Groups that shall be advisory to the Council and shall be responsible for the technical and other specified activities of the FIS.
- 2** The Committees, Sub-Committees and Working Groups may be appointed for the period between two ordinary Congresses or for a specified period.
- 3** The Chair and Members of the Committees and/or Sub-Committees should if possible belong to different Member Associations.

If a Chair and/or members of a Committee or Sub-Committee belong to the same Member Association, they have only one vote between them.

## PART B

### Joint Regulations for all Committees

The FIS Council specifies the tasks, rights and duties of a Committee.

#### 4 Appointment and members

- 4.1 The Council appoints Committees and any necessary Sub-Committees, Commissions and Working Group as **advisory bodies** to the Council. They shall deal with special fields of activities as determined by the Council.

All decisions of the Committees, Commissions and Working Groups, etc. **are subject to the approval** of the Council.

- 4.2 The members of Committees, Sub-Committees and Working Groups, etc. are appointed by the Council with the agreement of their National Ski Association in principle immediately after the conclusion of the Ordinary Ski Congress. The appointments are in force until the end of the next Ordinary Congress or for shorter period, as may be indicated. An outgoing member may be replaced (see also 10.5). A working group of the Council will review the proposals and applications from the National Ski Associations beforehand.
- 4.3 Members of the FIS Council may exceptionally be considered for membership of a Committee.
- 4.4 Membership of the Athletes' Commission is determined by election carried out by the athletes in the discipline concerned, in principle during the FIS World Championships. Only one athlete per National Ski Association may be elected and the Council shall confirm the results of the elections thereafter (see regulations for the Athletes' Commission).

#### 5 General Constitution

- 5.1 In principle technical Committees, and/or Executive Boards and technical Sub-Committees consist of a maximum of 7 regular members, special Committees of a maximum of 9 regular members, including the Chair and a Vice-Chair. One elected representative of the Athletes' Commission is additionally considered as a member of the respective Technical Committee. Only the FIS Council is empowered to decide regarding exceptions from this rule. In the Cross-Country, Ski Jumping, Nordic Combined, Alpine Skiing, Snowboard, Freestyle, FreeSki and other designated Committee's Conference, each affiliated National Ski Association may be represented.

5.2 In principle the National Associations may not be represented on the Committee by more than one regular member, with the exception of the special composition of Co-ordinating Committees, where several Committees are represented by their Chair or specially designated ordinary members, without regard to nationality.

5.3 The Council appoints the Chairs of the Committees and Sub-Committees as well as all other Committee Members and confirms the elections and membership of the Athletes' Commission.

National Ski Association nomination proposals for qualified members must include both genders if there is more than one member proposed, with the following targets:

- period 2020 - 2022: maximum 70% one gender
- period 2022 - 2024: maximum 60% one gender

In cases where the respective Committee has a Vice-Chair position, the Council will assign the Chair and Vice-Chair representing both genders where possible.

5.4 Each Committee may appoint a minute-taker (secretary) from amongst its members. For the Committees where the minutes are taken by a member of the FIS staff, this person is appointed by the Secretary-General.

## **6 Committee Members**

6.1 Only affiliated National Associations and the members of the FIS Council may propose candidates for the Committees and Sub-Committees. Candidates shall be appropriately expert in the field of activity for which they are proposed.

6.2 Affiliated National Associations wishing to propose candidates for Committees and Sub-Committees shall submit to the FIS Headquarters a written statement of each candidate's qualifications with their list of proposals for membership of the FIS Committees, by the deadline given in the circular letter of approximately 3 months before the Congress.

## **7 Travel Expenses, etc.**

7.1 A Member Association proposing a candidate for a Committee or a Sub-Committee who is later elected member of the Committee by the Council, undertakes the obligation to meet travel and hotel expenses incurred by the member in question when attending regular meetings of the relevant Committees.

7.2 When the FIS Council or the Presidency confers a special task on a Committee Chair, other Committee Member or group of Member bringing about travel expenses, the FIS will then be responsible for the travel and

hotel expenses as far as the FIS Competition Rules do not otherwise rule (as for instance Technical Delegates, Ski Jumping Judges, Inspectors, etc.).

- 7.3 Reimbursement of contribution to travel expenses is carried out according to regulations established by the FIS Finance Commission (appendix). Properly documented receipts are to be sent to the Finance Department at the FIS Headquarters.

## **8 Honorary Members**

The FIS Congress approved the following regulations for Honorary Members at its meeting in May 1990 in Montreux.

### **Honorary Awards**

For the services rendered to international skisport and for the activities fulfilled during long years with the FIS organisation structures, the FIS Congress and the FIS Council award the following titles and distinctions:

1. FIS Honorary President
2. FIS Honorary Member
3. Honorary Member of a FIS Committee
4. FIS Honorary Plaque or FIS Honorary Badge

#### **8.1 FIS Honorary President**

The FIS Congress can award the title of an Honorary President, after his retirement, to the FIS President having directed the FIS for 10 years at least and having rendered particular services to international skiing.

#### **Procedure**

Together with the appointment as FIS Honorary President, the FIS Honorary Badge as well as the FIS Honorary Diploma are conferred at the same time.

The proposal in view of the appointment as FIS Honorary President can be submitted by:

- the FIS Member Associations
- the FIS Council

#### **Prerogatives of the Honorary Members**

- The Honorary President is entitled to participate, without having the right to vote, in the FIS Congresses and in the meetings of the FIS Council.
- The Honorary President is entitled to participate in the World Championships and at the competitions contained in the FIS calendar and to be accredited like a Member of the Council.

## 8.2 FIS Honorary Members

The Congress can appoint as FIS Honorary Members, Members of the Council, Chairs of the Committees and other personalities, who have rendered, for 10 years at least, particular services to international skiing.

### **Procedure**

Together with the appointment as FIS Honorary Members the FIS Honorary Badge as well as the FIS Honorary Diploma are awarded at the same time.

The proposal in view of the appointment as FIS Honorary Member can be made by:

- the FIS Member Associations
- the FIS Council
- the individual Members of the Council
- the Working Group 'Titles and Distinctions'

### **Prerogatives of the Honorary Members**

The FIS Honorary Members are entitled to participate, without having the right to vote, in the FIS Congresses.

The FIS Honorary Members are entitled to participate in the World Championships and at the competitions contained in the FIS calendar and to be accredited like an ordinary Member of the Council.

## 8.3 Honorary Members of the FIS Committees

The members of the Committees who have, for 10 years at least, rendered particular services to international skiing within the FIS Committees can be appointed as Honorary members of a FIS Committee.

### **Procedure**

The proposal is made by the Committees. The appointment as Honorary Member is decided by the FIS Council by majority.

### **Prerogatives of the Honorary Members of Committees**

The Honorary members of the Committees can participate without having the right to vote, in the meetings of the Committees in question.

All the persons appointed as FIS Honorary President, FIS Honorary Members and FIS Honorary Members of the Committees are entitled to receive the FIS Bulletin free of charge.

These persons have no right to a reimbursement of their travel and accommodation expenses when they participate in the meetings of the Congress and the Committees or at a sports event.

### *4. Distinction with the FIS Plaque or the FIS Honorary Present*

The FIS Honorary Plaque or the FIS Honorary Present can be handed over by the FIS President or the FIS Secretary General.

### **Procedures by the Congress or the Council for the distinctions**

The Working Group 'Titles and Distinctions' of the FIS Council examines, on behalf of the Council, the proposals submitted in view of a distinction and submits to the Council its corresponding proposals.

The titles of FIS Honorary President, FIS Honorary Members and FIS Honorary Members of a Committee are awarded, as a rule, within the frame of a FIS Congress and published in the FIS Bulletin.

## **9 General Purpose**

- 9.1 The purpose of a Committee is:
  - 9.1.1 To advise the Council;
  - 9.1.2 To make recommendations, when found necessary, for alterations and revisions of the International Ski Competition Rules and other FIS Rules and Regulations, and
  - 9.1.3 To assist the Council and the FIS Headquarters in technical matters;
  - 9.1.4 To deal with all matters referred to the Committee, Commission, Sub-Committee or Working Group by the Council and to take measures which may lead to the furthering and development of the sport of skiing.
  - 9.1.5 To submit reports on the Committee's activities to the Council (publication in the FIS Bulletin, FIS Newsflash);
  - 9.1.6 To secure collaboration and to co-ordinate its work with other Committees.

## **10 Meetings, Minutes and Reports**

- 10.1 The Committees shall normally meet once a year. The Technical Committees concerned (Cross-Country, Ski Jumping, Nordic Combined, Alpine Skiing, Snowboard Freestyle, FreeSki and Para Snow Sport Committees) shall meet in time before the Congress in order to submit proposals to the Council. (please see Terms of Reference for the individual Committees and Sub-Committees in part 3 of these Rules).
- 10.2 For financial and practical reasons, invitations to Committee Meetings shall be issued only when there is work to be done. Guarantee must be given that the projected work is carried out at all meetings.
- 10.3 The Committee Chair has to send the invitations and agendas of the planned Committee Meetings for approval to the Secretary-General at least 8 weeks before the meeting.

- 10.4 Invitations for Committee Meetings to the members and to the delegated Council Members, including the Agenda, comments on the main items and accompanying documentation, have to be issued at least 6 weeks before the meeting ("at least 4 weeks notice is given").
- 10.4.1 The Committee may only make decisions respectively submit proposals to the FIS Council on items that were included on the draft agenda for the meeting, or added to the agenda and circulated in writing at least two weeks prior to the meeting.
- 10.5 If a regular member is unable to attend a meeting, a substitute may be appointed by his National Association (or by the main Committee in case of meetings of Committees with special constitution, e.g. Equipment Committee). The substitute shall present a written authorisation from his Association. The substitute shall be entitled to make proposals but has no vote.
- If a regular member does not attend three consecutive ordinary meetings of his Committee, his membership automatically expires. The National Ski Association concerned shall in this case propose a new member.
- 10.6 The Chair of a Committee has the right in an emergency to act on his/her own responsibility, with the permission of the FIS President or the Secretary-General. The Chair must report such action to the Committee Members as soon as possible.
- 10.7 It is the duty of the Chair of each Committee and Sub-Committee to keep minutes of the Committee meetings and as soon as possible after each meeting distribute the minutes to the members of the Committee, the FIS President, the Secretary-General, the delegated Council Members and to other addresses according to decisions taken by the Committee from time to time.
- 10.8 Agendas and minutes of each meeting which are prepared by the designated Committee member should be provided in electronic format, by e-mail, to the appointed member of staff at the FIS Headquarters in order that these may be properly formatted, distributed and loaded onto the Member Services section of the FIS website in order that the agendas and minutes of all FIS Committees are available to all National Ski Associations.
- 10.9 All National Associations shall be informed through the FIS Headquarters as soon as possible after the meeting about the actions and resolutions of the Committee through a summary of important matters in the FIS Newsflash.
- 10.10 It is also the duty of the Chair of each Committee to compile a report on the Committee's activities during the last 2-year's period, to be sent to the FIS Headquarters at a time decided by the Headquarters with due regard to the next International Ski Congress and the publication of the reports in the Congress edition of the FIS Bulletin and/or FIS Yearbook.

- 10.11 The Chairs of the Committees are responsible to submit for publication the reports on the activity of the Committees in the FIS Bulletin, as the content of such reports is considered of interest and importance for the FIS Members and for the activities of the different Committees.

## **11 Quorum – Voting**

- 11.1 The quorum for a Committee, resp. Sub-Committee is reached when half of the regular members of the Committee attend the meeting.
- 11.2 All Committees, Commissions and Working Groups are appointed as advisory bodies to the Council and all decisions are subject to the approval of the Council.
- 11.3 In the case of the need for an indicative vote, each regular member of the Committee and Sub-Committee including the designated representative of the Athletes Commission has one vote. If more than one delegate is from the same nation are on a Committee, only one vote per nation will be counted.
- 11.3.1 The Chair of the Committee has the right of vote, subject to art. 5.2 whereby only one representative per National Ski Association has the right to vote.

## **12 Finances**

- 12.1 Two months before each Congress, a Committee may present a budget for the coming 2-years' period. The budget shall show calculated costs for the activity of the Committee such as technical seminars, courses, projects, etc. (considering article 7).
- 12.2 The activity budget shall be studied and established by the Council (Finance Commission), after which the activity budget is approved.
- 12.3 At the end of each financial period, the Committee Chair shall send in to the FIS a rendering of accounts, following directions issued by the Finance Commission.
- 12.4 A Committee has no right to incur expenses other than those authorized in its budget as established by the Council.

## **13 Unforeseen Circumstances – Appeals**

- 13.1 All matters not specified in these regulations will be dealt with by the FIS President and the Secretary-General in consultation with the Committee Chairs concerned.

- 13.2 Decisions in accordance with 13.1 above which are considered of special importance are to be reported at the next Council Meeting.
- 13.3 Appeals against decisions according to 13.1 and 13.2 above may be made to the FIS Council.

## **PART C**

### **Terms of Reference and tasks of the different Committees and Sub-Committees**

#### **14 The Cross-Country Skiing Committee**

##### **14.1 General purpose**

- to follow and study cross-country competition sport, discuss its future and present to the Council proposals for its organisation, promotion and further sound development;
- to function as an instrument of co-ordination between officials, National Ski Associations, competition Organisers, teams, etc. and to collaborate with the FIS Headquarters;
- to submit to the Council rules and competition schedules on proposal of the Sub-Committees;
- to propose to the Council members of the jury for World Ski Championships and Olympic Winter Games;
- to nominate in collaboration with the FIS Headquarters and on proposal of the Sub-Committee for Rules and Control, the Technical Delegates for all international competitions with the exception of World Championships and Olympic Winter Games.
- to follow and study the development of the competition equipment and to submit viewpoints on new competition equipment to the Committee for Competition Equipment;

##### **14.1.1 Purpose of the Executive**

- to co-ordinate the work of the Sub-Committees, to act as an executive body in all questions regarding cross-country skiing and to advise the Council on all technical matters;
- to nominate and commission periodical Working Groups for special tasks.

##### **14.1.2 Purpose of the Cross-Country Committee**

- to co-ordinate the work of the Sub-Committees and to discuss the proposals of the Sub-Committees and Working Groups and to submit its viewpoints to the Council.

14.1.3 Purpose of the Conference

- to discuss the current status and the future of the Cross-Country sport and to act as an instrument of information between the Cross-Country Committee and the National Ski Associations.

14.1.4 Purpose of the Co-ordination Group

- to select and direct proposals for consideration by the relevant Sub-Committee.

14.2 Constitution

Executive: Chair + max. 7 regular members

Committee: Chair (the Chair of the Executive) + Chairs of the Sub-Committees + the members of the Executive + the Chair of the Committee for Nordic Combined + representatives from the 4 areas, if they are not already represented by the Chairs of the Sub-Committees or the members of the Executive + representative of the Athletes Commission.

Conference: each affiliated National Ski Association may be represented by one member.

Co-ordination Group: Race Director (Manager) for Cross-Country, Chairs of the Cross-Country Committee and the Sub-Committees.

14.3 Meetings

Executive: when necessary (in principle twice per year)

Committee: in principle once per year

Conference: in principle once per year

Co-ordination Group: when necessary and in good time prior to the Cross-Country Committee Meeting in order to select and circulate proposals to the Members and the National Ski Associations

**15 The Sub-Committee for Cross-Country Youth and Children's Questions**

15.1 Purpose

- to promote children's and youth activities in Cross-Country skiing and deal with questions relating to children's activities;
- to coordinate children's and youth Cross-Country skiing activities with the Cross-Country Committee and the different Sub-Committees;
- to collaborate with the appointed Nordic Combined expert
- to support and engage with the FIS Bring Children to the Snow campaign

15.2. Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

15.3 Meetings

In principle once per year.

## **16 The Sub-Committee for Women's Cross-Country Skiing**

### **16.1 Purpose**

- to deal with all questions concerning women's international Cross-Country skiing and present proposals for its promotion to the Cross-Country and the Council;
- to collaborate with the different Cross-Country Sub-Committees concerning rules, Cups and calendar questions, and with the Sub-Committees Women's Alpine concerning special women's questions, such as gender verification, medical examination, youth skiing, representation, etc;
- to work with the Sub-Committee for Rules and Control to propose to the Cross-Country Committee, members of the jury for World Ski Championships and Olympic Winter Games;
- to collaborate with and assist the Sub-Committee for Rules and Control propose Technical Delegates and officials.
- to actively participate with the organisation of the FIS seminars to promote women's snow sports.

### **16.2. Constitution**

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### **16.3 Meetings**

In principle once per year.

## **17 The Sub-Committee Cross-Country for Rules and Control**

### **17.1 Purpose**

- to present viewpoints and proposals to the Cross-Country Committee and the Council for the improvement of the competition rules or other measures having to do with the International Competitions Rules;
- to elaborate the exact wording of the rules in collaboration with the Committee and the different Cross-Country Sub-Committees;
- to supervise the wording of new editions of the International Competition Rules.
- to present viewpoints and proposals to the Cross-Country Committee and the Council for the improvement of the supervision and the control of cross-country skiing competitions;
- to co-ordinate Cross-Country homologation matters and the education of Cross-Country homologation inspectors;
- to supervise and to instruct the Technical Delegates in collaboration with the FIS Headquarters
- to organise technical seminars for the improvement of Technical Delegates with the approval of the Cross-Country Committee and the Council;
- to nominate in collaboration with the FIS Headquarters the Technical Delegates for all international competitions to control the organisation and carrying-out of the competitions, with the exception of World Ski Championships and Olympic Winter Games.

### **17.2. Constitution**

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### **17.3 Meetings**

In principle once per year.

**18 The Sub-Committee for Cross-Country World and Continental Cups**

18.1 Purpose

- to present to the Council and to the Cross-Country Committee proposals for rules for the Cross-Country World Cup and Continental Cup competitions;
- to propose the Calendar of the World Cup and Continental Cup competitions in collaboration with the FIS Headquarters, National Ski Associations and other parties concerned;
- to follow and analyse the development of the World Cup and Continental Cups;
- to decide in co-operation with the FIS Headquarters on last minute changes in the World Cup and Continental Cups schedule and to decide on a substitute organiser in case of cancellation of an event.

18.2. Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

18.3 Meetings

In principle once per year.

## **19 The Sub-Committee for Popular Cross-Country Skiing**

### 19.1 Purpose

- to deal with all questions concerning FIS Marathon, long-distance and mass races and to follow and study the development of popular Cross-Country skiing and to submit to the Cross-Country Committee and the Council proposals for the promotion of the sport;
- to collaborate with the Organisers of the main popular Cross-Country events and to propose the Calendar of international long-distance events;
- to propose guidelines for popular Cross-Country events in collaboration with the parties concerned.

### 19.2 Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### 19.3 Meetings

In principle once per year.

## **20 The Sub-Committee for Roller Skiing**

### 20.1 Purpose

- to deal with all questions concerning roller skiing races and to follow and study its development and to submit to the Cross-Country Committee and the Council proposals for the promotion of the sport;
- to collaborate with the Organisers of the roller skiing events;
- to elaborate the Calendars in collaboration with the National Ski Associations and to co-ordinate rules, schedules, quotas, etc;

### 20.2. Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### 20.3 Meetings

In principle once per year.

## **21 The Ski Jumping Committee**

### **21.1 General purpose**

- to follow and study Ski Jumping sport, discuss its future and present to the Council proposals for its promotion and further sound development;
- to function as an instrument of co-ordination between officials, National Ski Associations competition Organisers, teams, etc. and to collaborate with the FIS Headquarters;
- to submit to the Council rules and competition schedules on proposal of the Sub-Committees;
- to propose to the Council members of the jury for World Ski Championships and Olympic Winter Games;
- to nominate in collaboration with the FIS Headquarters and on proposal of the Sub-Committee for Officials, Rules and Control the Technical Delegates for all international competitions to control the organisation and carrying-out of the competitions, with the exception of World Championships and Olympic Winter Games;

#### **21.1.1 Purpose of the Ski Jumping Committee**

- to co-ordinate the work of the Sub-Committees and to discuss the proposals of the Sub-Committees and Working Groups, to act as an executive body in all questions regarding Ski Jumping and to advise the Council on all technical matters;
- to nominate and commission periodical Working Groups for special tasks.

#### **21.1.2 Purpose of the Conference**

- to discuss the current status and the future of the Ski Jumping sport and to act as an instrument of information between the Ski Jumping Committee and the National Ski Associations.

#### **21.1.3 Purpose of the Co-ordination Group**

- to select and direct proposals from the National Ski Associations for consideration by the relevant Sub-Committee.

## 21.2 Constitution

Committee: Chair (the Chair of the Executive) + Chairs of the Sub-Committees + the members of the Executive + the Chair of the Committee for Nordic Combined + representatives from the 4 areas, if they are not already represented by the Chairs of the Sub-Committees or the members of the Executive + representative of the Athletes' Commission.

Conference: each affiliated National Ski Association may be represented by one member.

Co-ordination Group: Co-ordinator for Ski Jumping, Chairs of the Ski Jumping Committee and the Sub-Committees.

## 21.3 Meetings

Committee: in principle once per year

Conference: in principle once per year

Co-ordination Group: when necessary and at least 3 weeks prior to the Ski Jumping Committee Meeting in order to select and circulate proposals to the Members and the National Ski Associations

**22 The Sub-Committee for Ski Jumping and Nordic Combined Youth and Children's Questions**

22.1 Purpose

- to promote children's activities in Ski Jumping and deal with questions relating to children's activities;
- to coordinate children's Ski Jumping activities with the Ski Jumping Committee and the different Sub-Committees;
- to engage in projects within the FIS Bring Children to the Snow campaign.

22.2. Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

22.3 Meetings

In principle once per year.

## **23 The Sub-Committee for Ski Jumping Hills**

### 23.1 Purpose

- to control construction standards;
- to propose directions for the construction and maintenance of Ski Jumping hills and their preparation for Ski Jumping competitions;
- to make proposals as far as it influences construction standards to the Committee and the Council;
- to examine homologation documents for Ski Jumping hills to be used for international competitions and to approve such hills in collaboration with the FIS controllers for Ski Jumping hills;
- to assist member countries in the design and construction of Ski Jumping hills;
- to issue homologation certificates for approved Ski Jumping hills.

### 23.2 Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### 23.3 Meetings

In principle once per year.

## **24 The Sub-Committee for Ski Jumping Calendar Planning**

### 24.1 Purpose

- to propose the Calendar of the World Cup, Continental Cup, Grand Prix and other FIS competitions in collaboration with the FIS Headquarters, National Ski Associations and other parties concerned;

- to endorse medical meetings that are of a beneficial nature to the development and safety of ski sport –as required or requested by the Council;
- to closely co-operate with the Technical Committees in all matters of medical nature;
- to actively support and cooperate with the Injury Surveillance System projects (ISS) and the involved expert institutions and persons;
- to inform the World Anti-Doping Agency about specific doping questions through the FIS Anti-Doping Expert;
- to work within the National Associations in education about doping and its harmful effects;
- to be responsible for the definition of gender verification tests and related controls as required by the Council or the Statutes;

Committee: Maximum 8-12 regular members, including the Chair  
(exceptions please see art. 5.1)

Coordination Group: Chair of the Medical Committee, one member per Discipline Working Group (Alpine/Freestyle/Snowboard, Nordic, Education, Medical Guide/Anti-Doping, ISS Project)

### **51.3 Meetings**

Committee: In principle once per year

Coordination Group: When necessary (in principle twice per year)

## **52 The Committee for Advertising Matters**

### **52.1 Purpose**

- to present to the Council proposals for the specifications and bye-laws of the rules on commercial markings on equipment, clothing and accessories;
- to monitor and where necessary present to the Council proposals for the FIS advertising rules at events (in accordance with the EBU rules);
- to discuss problems and be a body where the exchange of information about the various sponsor and supplier systems may take place;
- to be a contact organ between FIS and the ski industry in regard to commercial markings, sponsor and supplier programmes, etc.
- to liaise with the Committee for Public Relations and Mass Media on common matters to promote skiing and snow sports.

### **52.2 Constitution**

Committee: Maximum 8-12 regular members, including the Chair (exceptions please see art. 5.1).

### **52.3 Meetings**

In principle once per year.

## **53 The Committee for Public Relations and Mass Media**

### **53.1 Purpose**

- to provide input in regard to the format and content of the Bulletin (Yearbook) of the FIS and the weekly FIS Newsflash, in conformity with instructions and decisions by the Congress and/or the Council;
- to execute public relation's actions on order of the Council;
- to monitor media developments in various forms, including digital and social and propose appropriate updating of the regulations to the Council;
- to propose to the Council special public relation activities for the promotion of skiing;

to study and to follow up the history of skiing and supplement a FIS library on an ongoing basis;

- to present viewpoints and proposals for the improvement of the collaboration between FIS and the different media associations;

to liaise with the Committee for Advertising Matters on common matters to promote skiing and snow sports.

#### **53.1.1 Purpose of the Conference:**

- to exchange information about Public Relations in the various nations and to act as an instrument of information between the PR Committee and the National Ski Associations.

### **53.2 Constitution**

Committee: Maximum 8-12 regular members (exceptions please see art. 5.1).

Conference: each affiliated National Ski Association may be represented by one member.

### **53.3 Meetings**

In principle once per year.

## **54 The Committee for Competition Equipment**

### **54.1 Purpose**

- to collaborate with the responsible Technical Committees (Cross-Country, Ski Jumping, Nordic Combined, Alpine Skiing, Snowboard, Freestyle, FreeSki). The competitors' safety and health are to be taken into consideration and all matters regarding competition clothing and equipment shall be treated with due regard to fairplay and a sound development of the sport;
- to collaborate with the sports industry (Ski Racing Suppliers);
- to closely co-operate with the respective Sub-Committees or Working Groups for Rules or for Equipment of the Technical Discipline Committees;
- to work out and adopt uniform principles and directions for the approval of new developments in the field of competition equipment;
- to work out and publish lists of approved competition clothing and equipment in collaboration with the FIS Headquarters;
- to supervise in collaboration with the responsible Technical Committees and the competition jury the observance of directions and lists of approved articles of competition clothing and equipment;
- to establish exchange of experiences with similar Committees and Commissions within other International Sports Federations;
- to nominate in collaboration with the FIS Headquarters equipment controllers at international competitions for approval by the Council.

### **54.2 Constitution**

Maximum 8-12 regular members, including the Chair, in principle the Chair and Race Director or Coordinator of the Discipline Committee concerned + Chair of the Medical Committee + Chair of the Legal Committee + 2 representatives of the ski industry, SRS.

### **54.3 Meetings**

In principle once per year.

## **55 The Committee for European Questions**

### **55.1 Purpose**

- to assess specific issues affecting European skiing and make proposals to the FIS Council to address these;
- to share best practice relating to the development of skiing and snowboarding activities amongst European nations;
- to exchange ideas to encourage children and youth participation;
- to look into common training opportunities;
- to engage in FIS initiatives such as World Snow Day and Bring Children to the Snow including with other parties, such as tourist organisations, ski schools, etc.
- to undertake projects relating to European activities delegated by the FIS Council;

### **55.2 Constitution**

All European nations may propose members, including the Chair (exceptions please see art. 5.1).

### **55.3 Meetings**

In principle once per year.

## **56 The Committee for Racers with Special Qualifications**

### **56.1 Purpose**

- to follow and study competition sport for racers with special qualifications, discuss its future and present to the Council proposals for its promotion and further development;
- to experiment in following up all initiatives tending to simplify, facilitate, better organise and better control the competition sport for racers with special qualifications;
- to function as an instrument of co-ordination between officials, competition Organisers, competitors, etc. and to collaborate with the FIS Headquarters;
- to co-ordinate and control the activity of the different Sub-Committees and to exchange information between the Sub-Committees;
- to discuss proposals submitted by the Sub-Committees and to present them to the Council;
- to act as an executive body in all questions regarding competitions for racers with special qualifications;
- to nominate and commission periodical Working Groups for special tasks;

### **56.2 Constitution**

Chair + Vice-Chair + the Chairs of the 5 Sub-Committees.

### **56.3 Meetings**

In principle once per year.

## **57 The Sub-Committee for Alpine Citizen Racers**

### **57.1 Purpose**

- to develop competitions for Alpine citizen racers in and between countries and regions where special conditions, mostly climatical and geographical, make it difficult to reach top class;
- to present viewpoints and proposals to the Committee for Racers with Special Qualifications and to the Council;
- to elaborate the exact wording of the competition rules for Alpine citizen racers in collaboration with the Committee for Racers with Special Qualifications;
- to collaborate with the Alpine Skiing Committees in matters of common interest;
- to develop competitions for Alpine citizen racers and to follow and study the competition sport for Alpine citizen racers, discuss its future and present proposals for its promotion;
- to propose in collaboration with the FIS Headquarters to the Sub-Committee for Alpine Technical Delegates, the Technical Delegates for all international competitions for Alpine citizen racers.

### **57.2 Constitution**

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### **57.3 Meetings**

In principle once per year.

## **58 The Sub-Committee Cross-Country Development**

### **58.1 Purpose**

- to develop Cross-Country competitions in and between countries and regions where special conditions, mostly climatical and geographical, make it difficult to reach top class;
- to present viewpoints and proposals to the Committee for Racers with Special Qualifications and to the Council;
- to elaborate the exact wording of the rules in collaboration with the Committee for Racers with Special Qualifications;
- to collaborate with the Cross-Country Committees in matters of common interest;
- to propose in collaboration with the FIS Headquarters to the Sub-Committee for Rules and Control the Technical Delegates for all international Cross-Country competitions for lowlanders and citizen racers.

### **58.2 Constitution**

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### **58.3 Meetings**

In principle once per year.

## **59 The Sub-Committee for University Racers**

### 59.1 Purpose

- to develop and supervise competitions in the FIS disciplines for university racers;
- to present viewpoints and proposals to the Committee for Racers with Special Qualifications and to the Council;
- to elaborate the exact wording of the rules for competition for university racers in collaboration with the Committee for Racers with Special Qualifications;
- to collaborate with the Discipline Technical Committees in matters of common interest;
- to develop competitions in the FIS disciplines for university racers, discuss its future and present proposals for its promotion;
- to propose in collaboration with the FIS Headquarters to the respective FIS Sub-Committees the Technical Delegates for all international competitions for university racers;

### 59.2 Constitution

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### 59.3 Meetings

In principle once per year.

## **60 The Sub-Committee for Masters Racing**

### **60.1 Purpose**

- to develop Alpine and Nordic Masters competitions in and between countries and regions where special conditions, mostly climatical and geographical, make it difficult to reach top class;
- to present viewpoints and proposals to the Committee for Racers with Special Qualifications and to the Council;
- to elaborate the exact wording of the rules for masters competition in collaboration with the Committee for Racers with Special Qualifications;
- to collaborate with the Cross-Country and Alpine Skiing Committees in matters of common interest;
- to develop Alpine and Nordic Masters competitions and to follow and study the competition sport for masters, discuss its future and present proposals for its promotion;
- to propose in collaboration with the FIS Headquarters to the respective Alpine and Cross-Country Sub-Committees the Technical Delegates for all international masters competitions ;
- to establish liaison and co-operation with existing organisations, national and international, in this field.

### **60.2 Constitution**

Maximum 7 regular members, including the Chair (exceptions please see art. 5.1).

### **60.3 Meetings**

In principle once per year.

**61. The Committee for Para Snowsports**

**61.1. General Purpose**

- to follow and study Para Snowsports competition while defining its philosophy and to formulate “whole-of-sport” proposals to present to the FIS Council for its promotion and development
- to emphasize the harmonization of Para Snowsports and the able body disciplines within FIS
- to propose to the Council members of the jury for FIS World Para Snowsports Championships and Paralympic Winter Games;
- to present to the Council opinions regarding candidatures for the organisation of FIS World Para Snowsports Championships;
- to present viewpoints and proposals to the Council for the improvement of the competition rules or other measures having to do with the International Competitions Rules;
- to make in co-operation with the FIS Headquarters and National Ski Associations proposals for the international Snowsports calendars;
- to approve in collaboration with the FIS Headquarters on last minute changes in the Para Snowsports competition schedules and on a substitute organiser in case of cancellation of an event;
- to appoint members of the Working Groups and Advisory Groups per art. 63
- to nominate and commission periodical Working Groups for special tasks, and
- on request of the FIS Council, to provide advice about technical questions.

61.1.1 Purpose of the Executive Board

- to co-ordinate and supervise the work of the Sub-Committees, to act as an executive body in all questions regarding Para Snowsports and to advise the Council on all Para Snowsports technical matters;
- to co-ordinate and supervise the work of the Sub-Committees, to act as an executive body in all questions regarding Para Snowsports and to advise the Council on all Para Snowsports technical matters;
- to nominate and commission periodical Working Groups for special tasks.

61.1.2 Purpose of the Committee for Para Snowsports

- to co-ordinate and supervise the work of the Sub-Committees and Working Groups and to discuss, review, approve, return or reject the proposals of the Sub-Committees and Working Groups and to submit its viewpoints to the Council.

61.1.3 Purpose of the Conference

- to discuss the current status and the future of the Para Snowsports and to act as an instrument of information between the Para Snowsports Committee and the National Ski Associations.

61.2 Constitution

Executive: Chair, Vice-Chair, Chair of the Para Alpine Skiing Sub-Committee, Chair of the Para Nordic Skiing Sub-Committee, Chair of the Para Snowboard Sub-Committee, Chair of the Athletes Focus Group (\*\*\*)

Ex-Officio: Secretary General and/or Deputy Secretary General, Para Snowsports Managing Director,

Committee: Chair, Chair of the Executive Board, Vice-Chair, 5 to 7 NSA representatives, Chair of the Athletes Focus Group (\*\*\*), Chair of the Coaches Advisory Group (\*\*\*)

Conference: Each affiliated NSA not above represented may be represented by one member.

Ex-Officio: Para Snowsports Managing Director, Sports Coordinators, Chair of Para Classification and Factors Expert Group

61.3 Meetings

Executive: in principle once a month

Committee: in principle twice per year

Conference: in principle twice per year

## **62 The Sub Committees for Para Snowsports**

Para Alpine Skiing Sub-Committee  
Para Nordic Skiing Sub-Committee  
Para Snowboard Sub-Committee

### **62.1 Purpose**

- to serve as the custodians of their specific disciplines;
- to focus on event delivery issues including rules, course development and safety
- to present viewpoints and proposals to the Para Snowsports Committee for the improvement of the competition rules or other measures having to do with the International Competitions Rules;
- to elaborate the wording of the rules and supervise the wording of new editions of the International Competition Rules

### **62.3 Constitution**

Sub-Committee: Chair, Vice-Chair, 3 NSA representatives, Chair of the Athletes Focus Group, Chair of the Coaches Advisory Group

Conference: Each affiliated NSA not above represented may be represented by one member.

Ex-officio: Para Snowsports Managing Director, Sports Coordinator, Para Classification and Factors Experts

### **62.4 Meetings**

In principle once every two months

**63 Para Snowsports Working Groups (WG) and Advisory Groups (AG)**

The Para Snowsports Sub-Committees described in art. 62 may create Working Groups and Advisory Groups such as, but not limited to:

- Rules, Official and Regulations
- World Cup, Continental Cup and Development
- Para Equipment and Adaptive Equipment
- Athletes Focus Group
- Coaches Advisory Group

The members of the Working Groups will be appointed by the Para Snowsports Committee (see art. 61.1).

The Athletes Focus Group members will be nominated by the Athletes during the Para Snowsports World Championships and the Coaches Advisory Group by the Coaches at the same World Championships.

**64 Para Snowsports Expert Groups (\*)**

The Para Snowsports Expert Groups of Para Classification and of Factors are both here mentioned for didactic purposes as both do not constitute Council advisory bodies but are specific expert advisory bodies for Para Snowsports FIS Staff.

**65 FIS – IBU Joint Steering Committee (\*)**

The FIS – IBU Joint Steering Committee is also here mentioned for didactic purposes as it does not constitute Council advisory bodies but was created in accordance of the Cooperation Agreement signed by both International Federations on February 16<sup>th</sup>, 2022.

(\*) not an FIS Council advisory body

(\*\*\*) on rotation basis between the 3 disciplines

## **66 The Athletes' Commission**

### **66.1 Purpose**

- to discuss and address issues concerning Athletes in general;
- to present to the Council viewpoints and wishes from the Athletes;
- to serve as a liaison for the Athlete Commissions in all National Ski Associations and assist their set up;
- to liaise with the IOC and WADA and other appropriate Athletes Commissions;
- to propose their representative to the Congress to represent the Athletes' Commission in the Council;
- to appoint their representative in each discipline to serve as member of the Technical Committee/Executive Board.

### **66.2 Constitution**

At the time of their elections, which take place at the respective FIS World Ski Championships every two years, the Athletes must be active competitors who competed at the previous FIS World Championships or at World Cup level latest two years earlier than the election;

2 representatives of Alpine Skiing (one woman, one man),  
2 representatives of Cross-Country Skiing (one woman, one man),  
2 representatives of Ski Jumping (one woman, one man),  
2 representatives of Nordic Combined (one woman, one man),  
2 representatives of Snowboarding (one woman, one man),  
2 representatives of Freestyle Skiing (one woman, one man)  
2 representatives of non-Olympic (one woman, one man)

- the Chair is elected by the members;

### **66.3 Meetings**

In principle once per year in conjunction with the FIS Technical Committee Meetings, or major events where all disciplines are represented such as Olympic Winter Games.

**67 The Ethics Commission**

67.1 Purpose

- to ensure that the Code of Ethics is being respected
- to receive complaints regarding any infringement to the present Code of Ethics
- to give advice and assistance on ethical matters, particularly as regards the application of the present Code
- to advise on how to avoid or resolve conflicts of interest
- to recommend sanctions which could be taken against offenders of the present Code
- from time to time to recommend further measures for the application and amendment of the Code of Ethics
- to report to the FIS Council on the application of the present Code, listing any infringements to its rules. If necessary, the Ethics Commission shall also present a report to the FIS Congress.

67.2 Constitution

Maximum 3-4 regular members, including the Chair.

67.3 Meetings

When necessary.

## **68 The FIS Court**

### **68.1 Purpose**

to decide on matters brought to it in accordance with the FIS Statutes, Rules, Regulations based on the FIS Court Rules of Procedure;

- In accordance with the FIS Statutes, the FIS Court decides about:
- appeals against sanctions imposed by the Council and Appeals Commissions with the exception of doping cases;
- disputes between Member Associations;
- disputes between Member Associations and competitors as long as both parties are in agreement;
- other cases on request of the Council (see: regulations for disciplinary sanctions).

### **68.2 Constitution**

Maximum 7 regular members, including the Chair and Vice-Chair. The members must be independent and may therefore not have representative roles in a National Ski Association, Organising Committee or any FIS Committee.

Each Tribunal consists of three Judges appointed by the Chair of the FIS Court, who may be part of the Tribunal. Judges from countries whose National Ski Associations are involved directly or indirectly or are directly interested in the result of the case are not eligible for the Tribunal.

### **68.3 Meetings**

When necessary.

The Tribunal convenes or communicates by 'phone and electronically

**68 The Working Group for Timing and Data**

68.1 Purpose

- to establish criteria for the homologation of timing equipment to safeguard the accurate timing of competitions
- to control the accuracy of the timing at competitions through the analysis of timing reports
- to review the data format for the electronic submission of results
- to monitor and implement useful technical developments for timing and results management

69.2 Constitution

- Maximum 7 members including representatives of the timing and data companies and the FIS IT representatives

69.3 Meetings

When necessary, in principle 2 per year

**70 The Working Group for the FIS Development Programme**

70.1 Purpose

- to establish a programme to support developing National Ski Associations
- to co-ordinate various activities and projects for developing nations and the organisation of seminars
- to propose to the Finance Commission and Council a programme and budget in accordance with the available resources to include financial support for training activities, organisation of races, seminars, workshops, etc.
- to evaluate proposals for FIS Solidarity applications and make recommendations to the Council.

70.2 Constitution

Approximately 5 Council Members from different regions, ex-officio FIS Treasurer and 2-3 members from developing nations.

70.3 Meetings

When necessary, in principle 2 per year
